UPON ACCEPTANCE OF AMENDMENT**


COMES NOW Opposer, United Van Lines, LLC (“United”), by and through its counsel Thompson Coburn LLP, and pursuant to Fed. R. Civ. P. 41(a)(1), and Rule 2.106 of the Trademark Rules of Practice, hereby moves to withdraw the above-referenced opposition without prejudice. The opposition should be dismissed without prejudice, as no answer has been filed in the case.

The parties to the above-referenced opposition have settled this matter. Under the terms of the parties’ agreement, Applicant agreed to amend the description of goods and services listed in the identification of goods of the opposed application to replace the phrase in International Clas 39 “rental of construction, office and storage trailers” to now read “rental of storage containers and mobile offices for construction, events and temporary commercial activities.” Attached hereto as Exhibit A is Applicant’s amendment to the application. United consents to this amendment. Once the amendment attached hereto as Exhibit A is accepted by the Trademark Office, the opposition should be dismissed without prejudice.

WHEREFORE Opposer, United Van Lines, LLC, hereby withdraws without prejudice its opposition to the registration of Application Serial No. 78/561,655, upon acceptance of the amendment. Dated this 18th day of July, 2006.


