**APPLICANT'S RESPONSE TO OPPOSER'S RESPONSE TO APPLICANT'S MOTION  
TO EXTEND TIME TO ANSWER; AND OPPOSER'S REQUEST TO EXTEND  
DISCOVERY AND TESTIMONY PERIODS**

In Opposer's Response to Applicant's Motion to Extend Time to Answer and Opposer's Request to Extend Discovery and Testimony Periods, Opposer appears to object to Applicant's request for ninety (90) days to respond to Opposer's Notice of Opposition, but stipulates to a thirty (30) day extension of time, provided that all other deadlines are similarly extended.

As counsel for Opposer is no doubt aware, the Board routinely grants extensions of time in which to respond to an opposition for ninety (90) days, and Applicant is under no obligation to request consent or permission from Opposer to file a request for extension of time. Consequently, while Applicant acknowledges Opposer is willing to grant an additional thirty (30) days, Applicant requests that the Board grant an additional ninety (90) days in which to investigate this matter. Applicant further notes that two other entities have filed extensions of time in which to oppose Applicant's Application. Applicant is investigating all of these facts and circumstances in determination of its Answer.

Applicant is not opposed to extending all other deadlines for an additional ninety (90) days so as not to prejudice Opposer.
