MOTION FOR AN EXTENSION OF DISCOVERY AND TRIAL PERIODS

Opposer, GROWMARK, Inc., by its attorneys, respectfully moves for an extension of discovery and trial periods in the above matter. In support of its motion, Opposer states as follows:

1. The close of discovery is currently set for January 4, 2008, and Opposer requests that such date be extended for sixty days, or until March 4, 2008, and that all subsequent dates be reset accordingly.



Thus, Opposer requests that Discovery Period close on March 4, 2008; Thirty-day testimony period for party in position of plaintiff to close June 3, 2008; Thirty-day testimony period for party in position of defendant to close August 2, 2008; Fifteen-day rebuttal testimony period to close September 15, 2008.

3. The grounds for this request are that the parties are engaged in settlement discussions. Opposer contacted the office of counsel for Applicant yesterday by email and did not receive a response, and was unable to reach counsel for Applicant by telephone today. Thus,

Opposer was unable to secure the consent of Applicant, but is not aware that Applicant is opposed to Motion.


