NOTICE OF OPPOSITION

Valentino S.p.A., an Italian corporation, (hereinafter "Valentino") with an address at Via Turati, 16/18, Milano, Italy, believes that it will be damaged by registration of the mark RODOLFO VALENTINO for:

-- GLASSES, NAMELY EYE GLASSES AND SUNGLASSES IN CLASS 9

-- CLOCKS, WATCHES, JEWELRY, BRACELETS, NECKLACES,
EARRINGS, CUFF LINKS, RINGS, TIE CLIPS, PRECIOUS METAL MONEY
CLIPS; PINS, NAMELY, ORNAMENTAL LAPEL PINS AND TIE PINS,
CHARMS IN GOLD AND OTHER PRECIOUS METALS IN CLASS 14

-- LEATHER AND IMITATIONS OF LEATHER SOLD IN BULK, LUGGAGE TRUNKS AND TRAVELLING BAGS IN CLASS 18

-- CLOTHING, NAMELY SHIRTS, PANTS, COATS, TIES, JACKETS, SWEATERS, BLOUSES, SKIRTS, SUITS; FOOTWEAR AND HEADWEAR IN CLASS 25

as set forth in Application Serial No. 75/918,581, filed February 14, 2000, and published January 31, 2006 (hereinafter the "Application"), owned by IGAM S.p.A, with an address at Via Moscatello (Z.I), 70053 Canosa Di Puglia (BA), Italy, an Italian corporation (hereinafter "Applicant"), and hereby opposes the same. As grounds for this opposition, it is alleged that:

1. Since long prior to the filing date of Applicant's application, February 14, 2000, Valentino has extensively used, advertised and promoted the mark "VALENTINO", or "VALENTINO GARAVANI" with or without the "V and Design" and variations thereof, (hereinafter "the Valentino Marks") for a wide variety of clothing, cosmetics, spectacles, jewelry, leather goods, umbrellas and related accessories.

2. Valentino is the owner and user (by assignment or otherwise) of the following U.S. registrations and applications, among others:

- Registration No. 2,312,756, registered on February 1, 2000, for VALENTINO, for "spectacles frames and sunglasses" in Class 9;

- Registration No. 2,286,240, registered on October 12, 1999 for VERY VALENTINO for, perfume, eau de parfum, eau de toilette, body lotion, deodorant and bath and shower gel in class 3;
- Registration No. 2,755,270, registered on August 26, 2003 for VALENTINO GARAVANI and V Design for, *inter alia*, retail store services featuring cosmetics, eye glasses and sunglasses, jewelry, watches and clocks, stationery, leather or imitation leather articles such as bags, purses, briefcases, address books, journals, and shoes in class 35;
- Registration No. 2,880,581, registered on September 7, 2004 for, *inter alia*, Valises, garment bags for travel, handbags, shoulder bags, clutch bags, brief cases, attache cases in class 18; Articles of clothing, namely, men's and women's suits, trousers, coats, jackets, shirts, belts, sweaters, scarves, swim wear, gloves, raincoats, pajamas, robes, vests, slacks, shorts, socks, stockings, boots, shoes and slippers, women's blouses, skirts, dresses, gowns, hosiery and lingerie, and men's ties and suspenders in class 25;
- Registration No. 2,826,869, registered on March 30, 2004 for VALENTINO GARAVANI and V Design for, *inter alia*, spectacles frames and sunglasses in class 9; men's and women's jewelry, watches and clocks in class 14;

- Registration No. 1,153,226, registered on May 5, 1981 for VALENTINO for, *inter alia*, men's clothing-namely, suits, sport jackets, overcoats, shirts, trousers, bermuda shorts, and bathing suits in class 25;
- Registration No. 1,140,394, registered on October 14, 1980 for VALENTINO for, *inter alia*, umbrellas and parasols in class 18;
- Registration No. 0,910,955, registered on April 6, 1971 for VALENTINO for, *inter alia*, articles of clothing namely dresses, belts gloves, scarves, swimwear and ties in class 25;
- Registration No. 1,268,030, registered on February 21, 1984 for VALENTINO V and Design for, *inter alia*, articles of clothing, namely, jumpers, sweaters, dresses, skirts, blouses, suits, jackets, coats, shirts, trousers, vests, jeans, slacks, shorts, swimwear, hats, lingerie, ties, belts, scarves, hosiery and gloves in class 25;

3. Each of the above-mentioned registrations are valid and subsisting and Registration Nos. 2,286,240; 2,312,756; 1,153,226; 1,140,394; and 1,268,030 are incontestable. Copies of the registrations listed above are attached as **Exhibit A-1 to A-9** to the Notice of Opposition.

4. Valentino has prominently and extensively used, advertised and promoted its marks. The Valentino Marks are regularly advertised in leading fashion magazines such as *Vogue*, *Harper's*, *Elle*, *Women's Wear Daily*, *Cosmopolitan*, and *GQ*.

5. By virtue of the uncompromising and prestigious quality of the goods sold, advertised, and promoted under the Valentino Marks and by virtue of the extensive sales, promotion and advertising of such high quality goods for more than forty year, the Valentino Marks have become well-known and have acquired extensive recognition and strength throughout the United States.

6. The Valentino Marks are in the category of famous marks in the United States and acquired same fame long prior to 2000.

7. Upon information and belief, Applicant has not made use of the Application.

8. Upon information and belief, February 14, 2000, the date the Application was filed, is the earliest date Applicant can rely upon in this proceeding.

9. It is common practice for designers in the fashion industry to use their surnames as marks in connection with the sale of their apparel and accessories. Hence, especially in view of the fact that the goods and services of the Application are identical or closely related to Valentino's above-identified goods and services under the Valentino Marks, consumers and others familiar with the famous Valentino Marks will assume mistakenly that the opposed mark emanates from Valentino.

10. The opposed mark so closely resembles Valentino's previously used and registered marks that its use, in connection with the goods and services aforementioned, is likely to cause confusion, or to cause mistake or deceive, in violation Section 2(d) of the Trademark Act of 1946, 15 U.S.C. § 1052 (d). Purchasers likely will assume that Valentino is somehow affiliated with, licenses, or endorses, Applicant's use when

Valentino is not connected in any way with Applicant or the intended use by Applicant of
RODOLFO VALENTINO

11. If Applicant is permitted to use and register the opposed mark for the goods and services as specified therein, the damage to Valentino's goodwill and reputation will be enormous and irreparable. It would dilute the singular, distinctive and unique quality of the famous Valentino Marks.

12. The registration of RODOLFO VALENTINO will be inconsistent with the Valentino's rights in the aforementioned registrations and the common law and will be damaging to it.

WHEREFORE, Valentino prays that this opposition be sustained and registration on the Application be refused.
