**STIPULATION TO AMEND APPLICATION AND WITHDRAWAL OF OPPOSITION  
WITHOUT PREJUDICE**

The parties hereby stipulate to Applicant's amendment to the identification of services in International Class 41 of Application Serial No. 78/662,163 for the mark KIDSPY to delete the existing identification and substitute the following:

Opposer hereby withdraws the above-referenced opposition without prejudice, contingent upon the Board's entry of Applicant's amendment to the identification of
