6. Applicant admits that its application covers “wine” but otherwise denies the allegations set forth in ¶ 6 of the Notice.

7. Applicant is without information sufficient to form a belief as to the truth of the allegations set forth in ¶ 7 of the Notice, and, therefore, denies each and every such allegation.

8. Applicant denies the allegations set forth in ¶ 8 of the Notice.

9. Applicant admits that, if its Application No. 78/593,412 matures to registration, such registration will be *prima facie* evidence of the validity of applicant’s “exclusive right to use the registered mark . . . in connection with the goods . . . specified . . . , subject to any conditions or limitations . . . in the certificate” but otherwise denies the allegations set forth in ¶ 9 of the Notice.


10. Applicant denies the allegations set forth in ¶ 10 of the Notice.

WHEREFORE, Applicant requests that Opposition No. 91175002 be dismissed and that registration be granted to Application Serial No. 78/593,412.




