Comes now Applicant Vistar Corporation owner of application Serial Number 77/044,781 and responds to the numbered paragraphs in the Notice of Opposition filed by Opposer, as follows:

1. Admitted that Opposer has marketed food products at retail from one or more facilities in Clifton, NJ under a possessive form of a family surname Corrado since before applicant's first use of CORAZO but otherwise denied.
2. Admitted that Exhibit A is a copy of registration 3,131,690 but otherwise denied.
3. Admitted that Opposer has been selling its goods at retail and advertising its goods in NJ and on the Internet, otherwise denied.
