Each of the foregoing registrations is valid, subsisting, unrevoked and uncanceled. Said marks and registrations thereof are hereinafter collectively the GOOD FEET Marks.

4. By virtue of the sales and advertising of Opposer's aforesaid goods and services, including without limitation, its foot orthotics, cushions, arch supports, footwear and related goods and accessories marketed and sold under the GOOD FEET Marks and company brands, through retail company owned and franchised stores, through dealers, through marketing via Opposer's websites, infomercials, and other print and electronic advertising campaigns, said GOOD FEET Marks are recognized as identifying goods and services finding their origin or otherwise associated with Opposer.

5. The mark subject to this Opposition is FEELS GOOD FOOTWEAR, Application Serial No. 76/649,861, filed November 7, 2005 on the basis of intent-to-use in class 10 for orthopedic shoes and sneakers with custom orthoses, distributed exclusively through medical professionals. The Applicant's mark was filed subsequent to the Opposer's filing and first use dates in the aforesaid registrations. Opposer's filing and first use dates are clearly long prior to those of the Applicant.

6. Applicant, Feels Good Footwear, LLC is a Connecticut Limited Liability Company with its principal place of business at 559A Federal Road, Unit 5, Brookfield, CT 06804.

7. The Applicant's FEELS GOOD FOOTWEAR mark is confusingly similar to Opposer's GOOD FEET Marks and registrations. The respective marks are similar in sound, appearance, and overall commercial impression. The Applicant's mark and application contains the Opposer's mark in its entirety in the same juxtaposition and word order, and conveys the prominent GOOD FEET (GOOD FEET or GOOD FOOTWEAR) commercial impression. The goods and services of the parties offered under the respective marks are related. The respective goods and services are presumed to travel in the same or overlapping channels of trade and to be marketed to and purchased by the same or overlapping class of consumers. Opposer's goods

and services under the GOOD FEET Marks and registrations, and Applicant's related goods and services under the FEELS GOOD FOOTWEAR mark and application, are likely to be marketed through overlapping channels of trade, advertised in overlapping trade publications and used by an overlapping class of consumers. Accordingly, it is likely that consumers will mistakenly believe that Applicant's FEELS GOOD FOOTWEAR mark for orthopedic shoes and sneakers with custom orthoses, is associated in some manner with Opposer and the goods and services, sold or offered under Opposer's GOOD FEET Marks and registrations.


8. Registration of Applicant's FEELS GOOD FOOTWEAR mark for its goods and services would be inconsistent with Opposer's rights in its GOOD FEET Marks and registrations, and will cause damage to Opposer.

WHEREFORE, it is respectfully prayed that registration of the FEELS GOOD FOOTWEAR mark, Application Serial No. 76/649,861, not be permitted. Certified title and status copies of Opposer's registrations will be submitted during the course of the proceeding. I authorize you to deduct the filing fee in the sum of \$300.00 for this Notice of Opposition from the Procopio Cory Hargreaves & Savitch LLP Deposit Account number 502075.
