NOTICE OF OPPOSITION

The Chamberlain Group, Inc., a Connecticut corporation, located and doing business at 845 Larch Avenue, Elmhurst, Illinois 60126-1196 ("Chamberlain"), believes that it will be damaged by registration of the DOORMASTER trademark Application No. 78/965,234, and hereby opposes the same on the following grounds:

COUNT I - TRADEMARK INFRINGEMENT

1. In Application Serial No. 78/965,234, Advanced Biometric Solutions, Inc. ("Applicant"), is seeking to obtain registration on the Principal Register for the mark DOORMASTER for use in connection with "biometric security and identification software."

2. Since at least as early as May 17, 1967, Chamberlain adopted and began using the mark LIFTMASTER for use on security products including overhead door operating systems which are and have been marketed in commerce throughout the United States, as well as throughout the World.

3. On January 14, 1969, the United States Patent & Trademark Office registered on the Principal Register and issued, Registration No. 863,447 for the mark LIFTMASTER for use on residential electrical garage door controllers. Said Registration is presently valid and subsisting and is now owned by Chamberlain and is *prima facie* evidence of Chamberlain's exclusive right to use said mark in commerce on the goods. Said Registration is also incontestable under 15 U.S.C. § 1065.

4. On July 15, 1986, the United States Patent & Trademark Office registered on the Principal Register and issued, Registration No. 1,401,035 for the mark GARAGE MASTER for use on electronic garage door openers. Said Registration is presently valid and subsisting and is now owned by Chamberlain and is *prima facie* evidence of Chamberlain's exclusive right to use said mark in commerce on the goods. Said Registration is also incontestable under 15 U.S.C. § 1065. Chamberlain has made substantially continuous use in commerce of said mark on the said goods since at least as early as October 21, 1985.

5. On July 13, 1993, the United States Patent & Trademark Office registered on the Principal Register and issued, Registration No. 1,781,236 for the mark LIFT-MASTER for use on electrical door openers and structural parts thereof. Said Registration is presently valid and subsisting and is now owned by Chamberlain and is *prima facie* evidence of Chamberlain's exclusive right to use said mark in commerce on the goods. Said Registration is also incontestable under 15 U.S.C. § 1065. Chamberlain has made substantially continuous use in commerce of the said mark on the said goods since at least as early as May 17, 1967.

6. On January 28, 1997, the United States Patent & Trademark Office registered on the Principal Register and issued, Registration No. 2,034,080 for the mark ACCESSMASTER for use on radio receiver units, radio transmitter units, keypads card readers, control panels, and for controlling electronic door and gate openers, and parts therefor. Said Registration is presently

valid and subsisting and is now owned by Chamberlain and is *prima facie* evidence of Chamberlain's exclusive right to use said mark in commerce on the goods. Said Registration is also incontestable under 15 U.S.C. § 1065. Chamberlain has made substantially continuous use in commerce of the said mark on the said goods since at least as early as January 21, 1994.

7. On June 10, 2003, the United States Patent & Trademark Office registered on the Principal Register and issued, Registration No. 2,724,638 for the mark LIFTMASTER for use on in connection with “Electric motors for doors, gates and shutters; tubular electric motors for doors, gates and shutters; central vacuum system for residential use, comprised of central vacuum units, tubing and fittings; remote control systems and components thereof-namely radio controls for garage and warehouse entrance doors or gates, automatic garage door openers, lights, motors, antennas, transmitters, receivers and controllers responding thereto and used in such systems; electrical safety equipment; namely, an electric eye for sensing obstructions and controlling doors; electronic security devices, namely, electronic controls for granting access and egress through doors or gates; radio receiver units, radio transmitter units, keypads and card readers; a centralized automated system comprising a programmable controller, power line carrier modules, and one or more control modules or control receptacles, for controlling audio equipment, lighting, and other appliances in a residence; Providing technical advice and information in the maintenance and repair in the field of garage door opener installation, remote control systems, electrical safety equipment, electronic security systems and centralized automation systems; Providing research and design services for other enterprises regarding consumer, industrial, military and construction projects in the field of garage door openers, remote control systems, rolling shutters, awnings, telephone access systems, intercoms, electrical safety equipment, electronic security and centralized automation systems.” Said Registration is presently valid and subsisting and is now owned by Chamberlain and is *prima*

facie evidence of Chamberlain's exclusive right to use said mark in commerce on the goods. Chamberlain has made substantially continuous use in commerce of the said mark on the said goods since at least as early as May 17, 1967.

8. On January 23, 2007, the United States Patent & Trademark Office registered on the Principal Register and issued, Registration No. 3,201,915 for the mark GARAGE MASTER for use on in connection with "Remote controls for garage door openers". Said Registration is presently valid and subsisting and is now owned by Chamberlain and is *prima facie* evidence of Chamberlain's exclusive right to use said mark in commerce on the goods. Chamberlain has made substantially continuous use in commerce of the said mark on the said goods in interstate commerce since at least as early as October 21, 1985.

9. Chamberlain is the owner of all right, title and interest in the following Federal trademark registrations:

Chamberlain's adoption and its manner of use of the above-listed marks, constitute a "MASTER family of marks".

10. Long prior to Applicant's intended adoption of the DOORMASTER mark for the goods specified in the subject application, Chamberlain was actively engaged in interstate and foreign commerce in the business of manufacturing, distributing, advertising and selling the aforementioned security products and related products bearing the aforesaid marks and the MASTER family of trademarks.

11. Chamberlain has expended millions of dollars in advertising and promoting its products, and has sold millions of dollars of products bearing the aforesaid marks and the MASTER family of trademarks in the United States and throughout the world.

12. On information and belief, Applicant has intended to adopt the DOORMASTER trademark for the goods specified in the subject application with full knowledge of Chamberlain's famous aforesaid marks and its MASTER family of trademarks. Applicant has intended to use the trademark for those goods without the consent of Chamberlain with the intent to trade and capitalize on the goodwill generated by Chamberlain's extensive and exclusive use of its aforesaid marks and its MASTER family of trademarks.

13. Applicant's intended adoption, use, distribution, offer for sale, and sale of goods bearing the DOORMASTER mark for the goods specified in the subject application constitutes trademark infringement by causing confusion, mistake or deception as to the origin of the goods among the relevant consuming public. The public is likely to believe that Applicant's products originate with Chamberlain, are licensed by Chamberlain, or are sponsored, authorized, endorsed, or are otherwise related to Chamberlain.

14. On information and belief, the Applicant has not used the mark DOORMASTER on biometric security and identification software in interstate commerce.

15. On information and belief, the earliest date of actual or constructive use for the goods specified in the subject application upon which the Applicant can rely is August 31, 2006, the filing date of Application Serial No. 78/965,234.

16. The goods for which Applicant seeks registration of the DOORMASTER trademark are similar or related to the goods which Chamberlain distributes bearing the aforesaid marks and its MASTER family of marks.

17. On information and belief the goods for which Applicant seeks registration of the DOORMASTER mark are likely to be sold to the same customers or channels of trade to which Chamberlain sells its goods bearing the aforesaid marks and its MASTER family of marks.

18. Applicant's trademark as applied to the goods specified in the subject application is confusingly similar to Chamberlain's aforesaid marks and its MASTER family of marks, and use thereof is likely to cause confusion, mistake or deception that Applicant's goods are those of Chamberlain's, or are otherwise endorsed, sponsored or approved by Chamberlain.

COUNT II - FEDERAL TRADEMARK DILUTION

19. Paragraphs 1-18 are incorporated by reference herein.

20. Chamberlain has expended substantial monies in marketing, advertising and promoting its aforesaid marks and its MASTER family of marks on its goods.

21. Chamberlain possesses extremely valuable goodwill in the aforesaid marks and its MASTER family of marks by reason of its extensive use, marketing, publicity, advertising and geographic extent of its use and promotion. This goodwill was established long prior to the filing of this Application Serial No. 78/965,234.

22. Chamberlain has sold goods bearing the aforesaid marks and its MASTER family of marks in excess of millions of dollars.

23. The aforesaid marks and its MASTER family of marks are famous and distinctive within the meaning of the Lanham Act, and are entitled to the protection of the anti-dilution provisions of the Lanham Act, including 15 U.S.C. § 1125(c).

24. Applicant filed the Application after the aforesaid marks and the MASTER family of marks became famous and distinctive.

25. Chamberlain has expended substantial monies in marketing, advertising and promoting the aforesaid marks and its MASTER family of marks.

26. If Applicant is granted registration of its DOORMASTER trademark, Applicant will obtain the *prima facie* exclusive right to use such mark for the goods specified in the subject application, and such registration will impair, diminish, and dilute Chamberlain's goodwill and rights in its aforesaid marks and its MASTER family of marks. Therefore, Chamberlain opposes registration of Applicant's DOORMASTER trademark for the goods specified in the subject application pursuant to 15 U.S.C. § 1052 and 1063(a), as amended by the Trademark Amendment Act of 1999, which permits opposition of trademark applications filed on or after January 16, 1996 on grounds of dilution.


PRAYER FOR RELIEF
