**MOTION ON CONSENT TO CONTINUE SUSPENSION OF PROCEEDING
AND TO EXTEND DISCOVERY PERIOD IF OPPOSITION IS RESUMED**

Opposer’s counsel has re-drafted the settlement agreement based on negotiations with Applicant’s counsel and has sent the revised agreement to Opposer for review. The additional time is requested to allow Opposer to review the revised draft of the agreement and for the parties to continue with settlement negotiations. If accepted, the settlement agreement would resolve this matter without the need to continue with the opposition proceeding.
