OPPOSER'S OPPOSITION TO APPLICANT'S MOTION  
TO AMEND APPLICATION AND TO TERMINATE THIS OPPOSITION

Opposer, Crown Automotive Management, Inc. (hereinafter "CAMI"), hereby opposes Applicant's Motion to Amend Application (to one for concurrent registration) and to Terminate this Opposition. The present opposition proceeding, and Opposer's opposition to this Motion, are based upon the many years of usage by Opposer prior to first use by Applicant and derivation of Applicant's mark from Opposer. The Opposition is further based upon Opposer's extensive, nationwide use of the mark, and the existence of numerous third-party uses long prior to Applicant's presently opposed application for registration of the marks CROWN and CROWN AUTOMOTIVE for automobile dealership services.

BACKGROUND

In 1969, Dwayne Hawkins, Doug Willey, and Royce Reynolds moved to the St. Petersburg, Florida area and purchased a Pontiac dealership, naming it Crown Pontiac. Those three persons jointly owned the dealership, and Dwayne Hawkins managed and operated that dealership. In 1971, Royce Reynolds, Doug Willey, and their attorney bought a Mercedes Benz

dealership in Birmingham, Alabama, and began operating that dealership as Crown Automobile Company. Mr. Willey's wife continues to have an ownership interest in that dealership.

In 1972, Dwayne Hawkins, Royce Reynolds and Billy D. Eddleman purchased a Pontiac dealership in Greensboro, North Carolina and began operating it as Crown Pontiac, with the permission of all of the owners of the Crown Pontiac dealership in Florida. Within about two years thereafter, Royce Reynolds bought out the interest of Dwayne Hawkins in that North Carolina dealership. Subsequent to the purchase of the Greensboro Pontiac dealership, Royce Reynolds and Billy D. Eddleman purchased and opened several additional dealerships under the CROWN service mark in Virginia, North Carolina and Georgia. In 1984, Royce Reynolds bought out the interest of Billy D. Eddleman in the Crown auto dealerships located in Greensboro, North Carolina. Then, in 1998, Applicant Asbury Automotive Group, Inc. ("Asbury) bought the interest held by Royce Reynolds and Billy D. Eddleman in all of the Crown automobile dealerships in North Carolina and Virginia. (Eddleman Declaration, Exhibit A)

Subsequent to the purchase by Applicant Asbury of the Crown dealership from Messrs. Reynolds and Eddleman, Applicant Asbury began expanding the use of the CROWN service mark in connection with dealerships in North Carolina and South Carolina. Senior management personnel of Applicant Asbury's Greensboro, North Carolina dealership are fully aware of the involvement and ownership of Royce Reynolds, for whom they worked directly, prior to the acquisition of that dealership by Applicant Asbury, and they are aware of the Florida Crown dealership that preceded those in North Carolina.

CAMI is the parent corporation of the Florida and Ohio Crown dealerships, and Dwayne Hawkins remains a principal in it. CAMI, being located in Florida, where many persons from

the northern and eastern parts of the United States travel for vacations or second homes, has advertised for more than 30 years throughout the United States, first in newspapers of national circulation and, since 2003, over the Internet that extends to all parts of the United States. As a result of these solicitations throughout the United States, Opposer CAMI has been very successful in bringing residents of other states into the CAMI dealerships for the purchase of automobiles. During this time, Opposer CAMI has also continued to expand its chain of dealerships throughout Florida and in Ohio, with plans for additional expansion in other states. Opposer CAMI has also become aware of numerous third-party usages of the mark CROWN in numerous other states, including Alabama, Oklahoma, Texas, Kansas, Michigan, California, and others.

On June 17, 2008, after this opposition was instituted, Applicant Asbury proposed to Opposer to file the presently pending motion to dismiss this opposition proceeding and to convert the application to one for concurrent use, carving out the states of Florida, Ohio and Alabama, with Applicant Asbury claiming ownership in all other states. In an email response objecting to this proposal, Opposer advised Applicant that Opposer was prepared to prove the foregoing facts, specifically, that Applicant's first dealership to use the CROWN service mark was founded by former employees and continuing owners of Opposer CAMI, who requested and were given permission by CAMI to use the mark in North Carolina. Opposer CAMI further advised Applicant that Opposer would not accept any limitations on its long running use on the Internet for advertising of its dealership services. In that same email, a copy of which is attached hereto as Exhibit B, Opposer, on June 18, 2008, also advised Applicant of the numerous other third-party dealerships using the CROWN mark in states such as Alabama, Arkansas, Oklahoma, Kansas, Michigan and California, advising that such extensive use by numerous other parties

militates against a concurrent use application. (See Exhibit C, attached.) After Applicant Asbury received this email from Opposer, Applicant Asbury, on June 19, 2008, then filed the present Motion, disregarding the fact that it had been put on notice of both the derivation of its mark from Opposer, which was the prior user, and the numerous other third-party usages of the mark.

### LEGAL ANALYSIS

It is well established that an Applicant has the burden of proving that it is entitled to a concurrent use registration. 37 CFR § 2.99(e). Specifically, Applicant must prove facts sufficient to show that there is no likelihood of confusion arising from the proposed current use of the mark due, for example, to the different geographical areas of which they are to be used. See, *In Re Beatrice Foods Company*, 429 F.2d 466, 166 USPQ 431 (CCPA 1970).

Generally, concurrent rights arise when a party, in good faith and without knowledge of a prior party's use in another geographic area, adopts and uses the same or similar mark for the same or similar services within its own geographic area. TBMP 1103.01(d)(2). In the present matter, Applicant Asbury, through the management of its Greensboro, North Carolina facility, was or should have been fully aware of Applicant's derivation of the CROWN service mark from Opposer's prior use. The Greensboro, North Carolina facility was the first business entity now owned by Applicant Asbury to use the CROWN mark, and this entity was originally founded and named by one former principal of Opposer, Royce Reynolds, and one continuing principal of Opposer, Dwayne Hawkins, many years prior to Asbury's purchase of that facility from Mr. Reynolds. (Eddleman Declaration, Exhibit A) The Greensboro Pontiac dealership adopted and used the CROWN mark for dealership services, subsequent to, and with full knowledge of, the use of that CROWN service mark in St. Petersburg, Florida and Birmingham, Alabama, thus failing the threshold requirements for concurrent use rights. There can be no

question that Applicant Asbury, through the continuing management personnel at its Greensboro, North Carolina facility, was, or should have been, fully aware of this derivation, thus raising serious questions as to the legitimacy and truthfulness of the declaration filed by Applicant in the present application, in which Applicant asserted that no other party had the right to use any confusingly similar mark for similar services. Without more, this fact calls into question the legitimacy of the present application.


If a party to a concurrent use proceeding is relying on different geographical areas to show there is no likelihood of confusion, the Trademark Trial and Appeal Board (TTAB) generally considers such factors, *inter alia*, as:

1. A showing that each party will not use or advertise its marks in the geographical area of any other parties;
2. The parties have taken and will take whatever steps are necessary to prevent actual confusion;
3. The establishment of a buffer zone between geographical areas of the parties;
4. Information concerning any particular aspect of the services or channels of trade which may help to preclude likelihood of confusion. *See, Rice. "Concurrent Use Applications and Proceedings" 72 TMR 403, 1982.*

In the present matter, Opposer and dealers unrelated to Applicant are clearly in the same channel of trade and are using the CROWN service mark for auto dealership services in Florida, Ohio, Alabama, Michigan, Oklahoma, Texas, Kansas, Missouri and other states, as shown on the Internet web pages printed in Exhibit C. From these extensive uses on the Internet, it is clear that there is no situation in which each of the different users will not advertise or use the marks in the geographical areas of other parties. Opposer is prepared also to prove that Opposer's dealerships

in Florida and Ohio, in the past ten years alone, have sold about 1,000 automobiles to residents of North Carolina, South Carolina, and Virginia, the states in which Applicant Asbury is operating its Crown auto dealerships. Furthermore, unless the exclusive rights of Applicant were strictly limited to the states in which it is presently operating dealerships, there is no practical manner in which appropriate buffer zones can be created between the facilities, much less the advertising, of the various users. There is no substantive difference between the respective marks shown on Exhibit C, and the services are identical. Further, the numerous parties that would have to agree to such a concurrent use registration have neither taken nor agreed to take any steps necessary to prevent actual confusion of purchasers amongst the various users. For all the foregoing reasons, there is no legitimate basis for any concurrent use registration to be issued to Applicant Asbury. Likewise, there is no basis for terminating the present opposition proceeding at this time, except through judgment against Applicant and its currently pending application. TBMP 1103.01(4) Accordingly, Applicant's Motion should be denied.



DECLARATION OF BILLY D. EDDLEMAN

I, Billy D. Eddleman, hereby declare and state the following, of which I have personal knowledge:


1. From the 1960's until after 1998, I served as a certified public accountant for all of the Crown Auto Dealerships located in Florida and North Carolina, among other states.
2. In late 1969, Dwayne Hawkins, Royce Reynolds, and Doug Willey purchased an automobile dealership in St. Petersburg, Florida, naming it CROWN Pontiac, and Dwayne Hawkins managed and operated that dealership.
3. In 1971, Doug Willey, Royce Reynolds, their attorney and I bought a Mercedes Benz dealership in Birmingham, Alabama and began operating that dealership as Crown Automobile Company. Mrs. Willey continues to have an ownership interest in that dealership.
4. In 1972, Dwayne Hawkins, Royce Reynolds and I purchased a dealership in Greensboro, North Carolina and began operating it as CROWN Pontiac. Within about two years thereafter, Royce Reynolds bought out the interest of Dwayne Hawkins in that dealership.

5. After purchasing the Greensboro Pontiac dealership, Royce Reynolds and I purchased and opened several additional dealerships under the CROWN service mark in Virginia, North Carolina, and Georgia. The Georgia dealership was later sold to other parties.

6. In 1984, Royce Reynolds bought out my interest in the CROWN auto dealerships in Greensboro, North Carolina.

7. In 1998, Asbury Automotive Group Inc. bought the interests held by Royce Reynolds and myself in the CROWN automobile dealerships in North Carolina and Virginia.

I declare under penalty of perjury that the foregoing is true and correct. Executed this 30<sup>th</sup> day of June, 2008, in Birmingham, Alabama.

Mr. Zivin

We have reviewed your proposal for resolution of this opposition and hope that it may be possible for the parties to reach an agreement for resolution of this opposition proceeding without the necessity for a full and protracted proceeding.

Crown Automotive Management Inc. ("CAMI") is prepared to prove that the first Asbury dealership to use the CROWN mark was founded by former employees and owners of CAMI, who requested and were given permission by CAMI to use the mark in North Carolina. Management personnel at that dealership are fully aware of this fact. Accordingly, CAMI is not prepared to accept any limitations on its rights to use the mark based upon any attempted registration at the USPTO. Likewise, CAMI will not accept any limitations on its long-running use of the internet for advertising its dealership services.

We believe it unlikely that the PTO would agree to register any concurrent use applications, in view of the potential for consumer confusion. From my experience, it is unlikely that the PTO would agree to any concurrent use applications that do not provide for some sort of a buffer between the various users of the mark, especially in view of the pervasive internet advertising of the dealerships. As both parties, through their management personnel, are also aware of other, third-party auto dealerships using the Crown mark (in Alabama, Arkansas, Oklahoma, Kansas, Michigan, California, etc.), any such concurrent use applications would require additional carve-outs for them, in order to have truthful declarations for such concurrent use applications. This, of course, raises additional issues with respect to the declaration in the currently pending application.

For all the foregoing reasons, CAMI believes that the most appropriate course of action is for Asbury to withdraw its pending application and allow the numerous dealership users of the CROWN mark to continue the uses of the mark that have existed for more than 30 years, asserting whatever rights they may have under common law.
