NOTICE OF OPPOSITION

MIP METRO Group Intellectual Property GmbH & Co. KG ("Opposer"), a German GmbH & Co. KG with its principal place of business at Metro-Strasse 1, 40235 Duesseldorf, Germany, believes that it will be damaged by the registration of the mark IT'SFASHIONMETRO as shown in Trademark Application Serial No. 77/227,963, filed on July 12, 2007, in International Classes 9, 14, 18, 24 and 35, published for opposition in the Official Gazette of June 10, 2008, Vol. 1331, No. 1, at Page TM92.

1. Opposer, MIP METRO Intellectual Property GmbH & Co. KG, is a GmbH & Co. KG duly organized and existing under the laws of the Germany, having its corporate address and a principal place of business at Metro-Strasse 1, 40235 Duesseldorf, Germany.

2. Opposer is the owner of U.S. Trademark Serial No. 78/581,586 for the mark METRO & Design and U.S. Trademark Serial No. 78/632,210 for METRO CASH & CARRY (hereinafter "Opposer's Marks"), both of which covers services highly similar to those listed in the subject application and related to the goods. In particular, Opposer's application covers "retail store services, wholesale stores and wholesale distributorships, all featuring food and general merchandise" in Class 35. Said applications are the exclusive properties of Opposer and is in all respect valid and subsisting, a printout of which from the USPTO TARR website is attached hereto collectively as Exhibit A.

3. Opposer filed its trademark applications on May 7, 2005 and May 18, 2005 respectively, long prior to July 12, 2007, Applicant's filing date.

4. Opposer's Marks METRO & Design and METRO CASH & CARRY are arbitrary as applied to Opposer's services. Opposer's Marks are thus highly distinctive and serve as a strong indicator of origin.

5. There is no issue of priority since Opposer's filing dates precede Applicant's filing date.

6. Applicant's IT'SFASHIONMETRO (Stylized) mark (hereinafter "Applicant's Mark") and Opposer's Marks are highly similar visually and aurally.

7. The goods and services for which Applicant seeks registration of the IT'SFASHIONMETRO (Stylized) mark are highly similar to the services for which Opposer has filed its application. The services to be marketed by Opposer are offered to the same consumers, and are thus in competition with the goods and services to be marketed and sold by Applicant.

8. Applicant's Mark is confusingly and deceptively similar to Opposer's Marks and is likely to cause confusion and mistake in the minds of the purchasing public and to deceive the purchasing public as to the source or origin of Applicant's services. Persons familiar with Opposer's Marks would be likely to believe that Applicant's goods and services originate with or are sponsored by Opposer. Any such confusion in the trade could seriously injure Opposer to the extent that any objection or fault found with Applicant's

services marketed under its mark would necessarily reflect upon the reputation which Opposer will establish for its services to be offered under its trademark.

9. If Applicant were granted registration for the subject mark, it would hereby obtain at least a *prima facie* exclusive right to the use of its mark. Such registration and use would be a source of damage and injury to Opposer and Opposer's customers.

WHEREFORE, Opposer, believes and avers that it is being and will continue to be damaged by registration of the mark with respect to International Classes 9, 14, 18, 25, and 35 as aforesaid, and prays that said Application Serial No. 77/227,963 be rejected, that no registration be issued thereon to Applicant, and that this Opposition be sustained in favor of Opposer.

Opposer has appointed Mark H. Tidman, John H. Weber and Kelu Lu, members of the law firm of BAKER & HOSTETLER LLP to prosecute this opposition proceeding and to transact all business in and before the United States Patent and Trademark Office in connection herewith. 

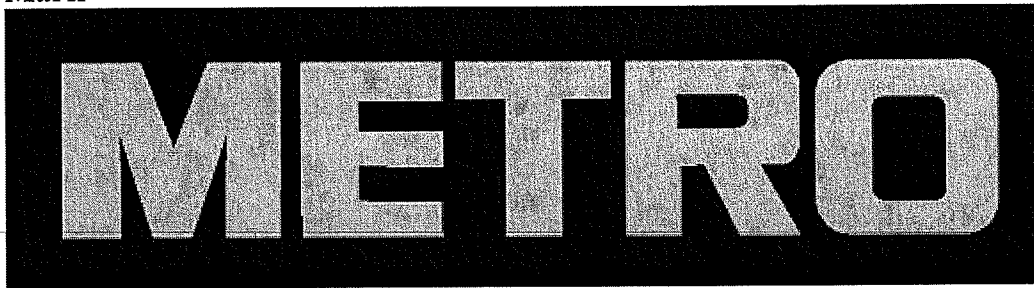
