NOTICE OF OPPOSITION

Opposer, DSM IP Assets B.V., a besloten vennootschap, with a business address of Het Overloon 1, Heerlen, The Netherlands NL-6411 TE, hereby opposes registration of the mark IFLEX that is the subject of application Serial No. 77489829, published on December 16, 2008, and requests that registration to Applicant be refused.

As grounds in support of its opposition, Opposer asserts as follows:

- 1. Opposer, since prior to any date of first use upon which Applicant can rely, has contrived, adopted and used the term I-FLEX as a trademark for health related goods.
- 2. Opposer is the owner of U.S. Trademark Registration No. 3468122 for the I-FLEX trademark covering:

Class 5 - Dietetic preparations and substances adapted for medical use, namely, dietetic foods adapted for medical use, dietary and

nutritional supplements; food supplements for medical use; dietetic beverages adapted for medical purposes; vitamins; vitamin preparations; natural medicines, namely, natural pharmaceutical preparations for the treatment and prevention of osteoarthritis and similar conditions, namely, treating and preventing flexibility or mobility conditions,

Class 29 - Preserved, frozen, dried and cooked fruits and vegetables; jellies, jams, compotes; edible oils,

Class 30 - Flour; preparations made from cereals, namely, breakfast cereals, ready to eat cereal derived food bars; bread, pastry; biscuits; cookies; tea; tea-based beverages,

Class 31 - Flower, fruit, wheat seeds; natural plants and flowers; fresh fruits and vegetables, and

3. Opposer is the owner of U.S. Trademark Registration No. 3445050 for the stylized "i-flex ... i can flex freely" trademark (one of Opposer's "I-FLEX trademarks") covering:

Class 5 - Dietetic preparations and substances adapted for medical use, namely, dietetic foods adapted for medical use, dietary and nutritional supplements; food supplements for medical use; dietetic beverages adapted for medical purposes; vitamins; vitamin preparations; natural medicines, namely, natural pharmaceutical preparations for the treatment and prevention of osteoarthritis and similar conditions, namely, treating and preventing flexibility or mobility conditions,

Class 29 - Preserved, frozen, dried and cooked fruits and vegetables; jellies, jams, compotes; edible oils,

Class 30 - Flour; preparations made from cereals, namely, breakfast cereals, ready to eat cereal derived food bars; bread, pastry; biscuits; cookies; tea; tea-based beverages,

Class 31 - Flower, fruit, wheat seeds; natural plants and flowers; fresh fruits and vegetables, and

This registration is valid, subsisting, unrevoked and uncancelled.

- 4. Applicant has filed an application to register the mark IFLEX PRODUCTS for health related goods, i.e., "Exercise machines; Manually-operated exercise equipment; Personal exercise mats," in Class 32. The application was filed on June 3, 2008, and was assigned Serial No. 77489829. The application was filed as an "intent to use" trademark application. No statement of use has been filed. The Applicant has disclaimed the term "PRODUCTS" in its trademark. The USPTO assigned "I FLEX PRODUCTS" as a pseudo mark to the Applicant's mark.
- 5. Applicant's IFLEX PRODUCTS trademark for health related goods so resembles Opposer's previously used and registered I-FLEX trademarks for health related goods as to be likely, when used in connection with or in association with the health related goods set forth in Applicant's application, to cause confusion, mistake or deception within the meaning of Section 2(d) of the Trademark Act. Among other things, consumers are likely to believe that Applicant is somehow associated with, affiliated with, or licensed by Opposer in view of Opposer's usage and/or registration of its I-FLEX trademarks and Applicant's usage or intended usage of the IFLEX PRODUCTS trademark on similar or related goods.

WHEREFORE, Opposer prays that the opposition be sustained and that registration to Applicant be refused.
