**MOTION ON CONSENT TO AMEND APPLICATION AND,
IF ACCEPTED, TO WITHDRAW THE OPPOSITION ON CONSENT**

Pursuant to Rule 2.133 of the Trademark Rules of Practice, Applicant respectfully requests, with Opposer's consent, that the above-captioned application be amended by adding the bolded language "**not relating to sports or a sports team**" to the end of the description of goods, which should now read:

PET BEDS NOT RELATING TO SPORTS OR A SPORTS TEAM in
International Class 20

It is respectfully submitted that this amendment does not require republication as the amendment of the description of goods narrows rather than broadens the scope of the application.


