NOTICE OF OPPOSITION

Fitz-Wright Company Ltd., a corporation of Canada, having its principal place of business at 5760 Production Way, Langley, British Columbia, V3A 4N4, Canada, believes that it will be damaged by registration of the mark B in Design shown in Application Serial No. 77/420,450 in International Classes 25 and 28 and hereby opposes the same.

As grounds for opposition, Opposer alleges that:

1. Opposer and its related companies are engaged in the manufacture and sale of, *inter alia*, apparel and accessories, particularly for water sports.

2. Since long prior to Applicant's priority date, Opposer and its related companies have continuously and extensively used in commerce the mark B in Design, in connection with the sale of apparel and accessories, particularly for water sports.

3. Opposer is the owner of Registration No. 3317065 of the mark B in Design issued October 23, 2007 on the Principal Register. Said registration is valid and subsisting.

4. Through the widespread use and advertisement of its B in Design mark over a long period of time and by virtue of the quality of the goods sold under the mark, Opposer has built up a valuable goodwill and reputation in connection with said mark, which would be

jeopardized by Applicant's use and registration of the mark B in Design shown in Serial No. 77/420,450.

5. The goods for which Applicant seeks to register the mark B in Design, namely, wetsuits, rashguard shirts, rashguard shorts, beanies, visors, hats, head bands, shirts, shorts and tee shirts, paddleboards and surfboards, are closely related to Opposer's apparel and accessories, particularly for water sports, previously sold under or in connection with Opposer's B in Design trademark.

6. Applicant's mark B in Design so resembles Opposer's B in Design trademark, previously used in commerce and registered with the United States Patent and Trademark Office, and not abandoned, as to be likely, when applied to the goods of Applicant, to cause confusion, or to cause mistake or to deceive.

7. Opposer is informed and believes that Applicant did not use the mark B in Design in connection with any of the goods in Class 25 prior to its filing date.

WHEREFORE, Opposer prays that this opposition be sustained and that registration of Application Serial No. 77/420,450 be refused.
