Applicant, Kaba AG hereby requests that the description of goods in Application No. 79/053840 for AXESSOR be amended by:

- (a) deleting Class 6, namely non-electric locks of metal, keys of metal and replacement parts therefore, namely, metal ball lock pins, metal lock cylinders; cash boxes, safes and armored cabinets in the nature of metal safes, safe installations, namely, metal fire resistant safes, safe deposit boxes, strong room doors, safety cabinets in the nature of metal safes, all aforementioned goods made of metal in its entirety; and
- (b) amending Class 9 from "electrically, electronically, acoustically and optically controlled security, locking and access control devices, namely, computer hardware and software for securing and access to Automatic Teller Machines, safes, strong room doors, data cabinets, gun

safes, trucks for money transport in the nature of cash in transit vehicles, server cabinets, key safes and steel doors" in Class 9" to electronically controlled security, locking and access devices, namely electronic safe locks and parts of electronic safe locks and computer software related to electronic safe locks.

The proposed amendment is limited in nature and thus in compliance with Trademark Rules 2.71 and 2.75. Opposer The Hillman Group, Inc., expressly consents to the entry of the above amendment in accordance with Trademark Rule 2.133.

Opposer has provided its written consent to this amendment.

Provided the amendment is accepted and approved, Opposer withdraws the Opposition with the consent of Applicant.
