Please amend the goods to read:

Absorbent paper for tobacco pipes; ashtrays, not of precious metal, for smokers; mouthpieces of yellow amber for cigar and cigarette holders; firestones, namely, lighter flints; lighters for smokers, liquefied gas containers for cigar lighters; chewing tobacco; mouthpieces for cigarette holders; smoking pipe cleaners, smoking pipe racks; snuff, snuff boxes, not of precious metal; spittoons for tobacco users, not of precious metal; matches; match boxes and matches holders, not of precious metal; tobacco; tobacco pouches, tobacco jars, not of precious metal; tobacco

pipes; pocket machines for rolling cigarettes; cigarettes containing tobacco substitutes, not for medical purposes; cigarette cases, not of precious metal; cigarette and cigar filters; cigarette tips; cigarette paper, books of cigarette papers; cigarette holders, not of precious metal; cigar cutter; cigar cases, not of precious metal; humidors; cigar holders, not of precious metal.
