REPORT ON DETERMINATION OF APPLICATION SERIAL NO. 76/686,838


Pursuant to the Board’s request in the order issued January 29, 2014, the parties hereby submit the following report regarding their agreement as to the determination of Application Serial No. 76/686,838 for the mark 3RD BASE SPORTS BAR & GRILL.

As stated in Applicant’s Express Abandonment of Application Serial No. 76/686,837, submitted in connection with the Rule 41(a) Stipulation of Dismissal filed by the parties on January 21, 2014, Applicant assigned any and all common law rights and related goodwill relating to the marks “THIRD BASE,” “3RD BASE,” and all formatives of such marks to 3BH, LLC. Consistent with such assignment, Applicant also assigned Application Serial No. 76/686,838 for the mark 3RD BASE SPORTS BAR & GRILL to 3BH, LLC. Consequently, 3BH, LLC is the current owner of the mark 3RD BASE SPORTS BAR & GRILL and

Application Serial No. 76/686,838 therefor. The assignment was recorded with the Assignment Services Division of the USPTO on January 21, 2014 at Reel/Frame 5197/0327.

In view of the assignment of the subject mark and application to 3BH, LLC, the parties hereby respectfully reiterate their stipulation to dismiss the present opposition proceedings without prejudice pursuant to Rule 41(a)(1)(A)(ii).
