NOTICE OF OPPOSITION

The Travelers Indemnity Company ("Travelers"), a corporation of the State of Connecticut, having a principal place of business at One Tower Square, Hartford, Connecticut 06183, believes that it is being damaged, and will be damaged, by the registration of the mark shown above in Application Serial No. 77414969, and hereby opposes the same. As grounds for opposition, Travelers alleges that, upon actual knowledge with respect to Travelers' own acts, and upon information and belief as to other matters:

Travelers and Its Umbrella Mark

1. Opposer, The Travelers Indemnity Company, is a corporation of the State of Connecticut, having a principal place of business at One Tower Square, Hartford, Connecticut 06183.



2. Travelers, through its predecessors and related companies (collectively "Travelers"), has been in the insurance business for more than 130 years. It is one of



the world's leading providers of a wide variety of insurance and surety products and services to businesses, organizations, and individuals in the United States.


3. Travelers first used an umbrella design in commerce in connection with advertising and promoting insurance services in the 1800s, and the umbrella mark shown below has been Travelers' official corporate logo since at least 1961 in connection with, among other things, insurance services and other financial services.



4. Travelers owns, among others, the following valid and subsisting United States trademark registrations for the marks shown below (collectively "Travelers' Umbrella"). Printouts from the PTO TESS/TARR and Assignment databases are attached as Exhibit A.

5. The foregoing registrations in Paragraph 4 are valid and subsisting. These registrations constitute *prima facie* evidence and conclusive proof of Travelers' ownership of and exclusive rights to use the marks in connection with the services recited in the registrations.

6. Travelers has established considerable and valuable trademark rights and goodwill in the Travelers' Umbrella mark by virtue of its long use of the mark, its substantial promotional and marketing efforts, its expenditure of vast sums in advertising and promotional activities, the strong sales of services offered in connection with the mark, and third-party acclaim and attention.

7. Over the years, revenues generated from services offered, sold, and advertised in connection with Travelers' Umbrella mark have been immense. For example, Travelers has enjoyed revenues of more than one hundred billion dollars since 2004 alone, including 2008 revenues exceeding \$24 billion dollars. Further, Travelers has expended many millions of dollars over the years advertising and promoting its services under the Travelers Umbrella, including tens of millions of dollars each year in recent years.

8. As a result of the long and extensive use of Travelers' Umbrella mark, and its significant sales, promotion, advertising, third-party acclaim, and commercial success, Travelers' Umbrella mark has achieved such widespread public exposure and recognition that it possesses a high degree of distinctiveness and has been well-known and famous in the United States for many years.

New Empire and Its Umbrella Mark

9. Applicant New Empire Group, Ltd. ("New Empire") is a corporation of the State of New York, having an address of 214 West Park Avenue, Long Beach, New York 11561.

10. New Empire is the identified owner of intent-to-use Application Serial No. 77414969, filed March 6, 2008, under Section 1(b), 15 U.S.C. §1051(b), and seeks registration of the mark shown below ("New Empire's Umbrella") for "insurance management services in the nature of insurance administration services for others; management of insurance risk purchasing groups, namely, financial risk management services in the field of insurance; insurance agency and brokerage services; insurance administration services, namely, management of insurance programs and premiums for others" in International Class 36.



LIKELIHOOD OF CONFUSION, 15 U.S.C. §1052(d)

11. Travelers repeats and realleges each and every allegation set forth in Paragraphs 1 through 10.

12. Travelers has priority based on its pleaded valid and subsisting prior issued registrations for Travelers' Umbrella mark. The Travelers' Umbrella mark has been in continuous use in commerce since before the March 6, 2008 filing date of New Empire's Application Serial No. 77414969 and before any date of first use alleged by New Empire.

13. Application Serial No. 77414969 for New Empire's Umbrella mark covers services that are identical or closely related to those offered, sold, and advertised by Travelers in connection with Travelers' Umbrella. Travelers' Umbrella registrations and New Empire's Application Serial No. 77414969 cover the identical services in the insurance field, including but not limited to, insurance administration services, insurance agency and brokerage services, and financial and risk management services.

14. New Empire's Umbrella mark so resembles Travelers' prior used and registered Travelers' Umbrella mark as to be likely, when used in connection with New Empire's services, to cause confusion, or to cause mistake, or to deceive under Section 2(d) of the Lanham Act, as amended, 15 U.S.C. §1052(d).


