1. Applicant has reached an agreement with Opposers Apotheke, LLC, Heather Tierney, Christopher Tierney and Eric Lopez to resolve the claims asserted in Case No. 12-24315-MCG before the United States District Court of the Southern District of Florida (the “Federal Court Litigation”) and Opposition No. 91192645 before the Trademark Trial and Appeal Board (the “Opposition”).
