For purposes of this Notice, all of the LITTLEMISSMATCHED trademarks of Opposer, including the above referenced U.S. trademark Registrations and Applications, will be referred to as the "LITTLEMISSMATCHED Marks".

3. Since prior to Applicant's filing date and its alleged priority date, Opposer (or its predecessors-in-interest) has used the LITTLEMISSMATCHED Marks in commerce on or in connection with goods, and retail services featuring goods, that are identical or closely related to Applicant's Goods ("Opposer's Goods and Services").

4. Opposer has promoted and continues to promote the LITTLEMISSMATCHED Marks in interstate commerce within the United States for identifying Opposer's Goods and Services.

5. Opposer's LITTLEMISSMATCHED Marks are inherently distinctive and uniquely associated with Opposer in connection with Opposer's Goods and Services offered under the LITTLEMISSMATCHED Marks by reason of Opposer's extensive advertising, promotion and use. Such advertising, promotion and use occurred prior to the filing date and alleged priority date of the Application.

Applicant's LITTLE MISS NAUGHTY mark so resembles Opposer's
LITTLEMISSMATCHED Marks as to be likely, if used in conjunction with Applicant's Goods, to cause confusion, mistake, and to deceive customers.

7. Applicant's Goods are directed to the same or related class of customers as those for Opposer's Goods and Services and or will be sold in the same channels of trade. Accordingly, Applicant's LITTLE MISS NAUGHTY mark is confusingly and deceptively similar to Opposer's LITTLEMISSMATCHED Marks when used in connection with Applicant's Goods. 8. Applicant's use of its LITTLE MISS NAUGHTY mark under the Application, which so resembles and is colorably imitative of Opposer's LITTLEMISSMATCHED Marks, is likely to cause confusion, mistake or deception of purchasers as to the source of Applicant's Goods and will falsely suggest that Applicant's Goods are sponsored, endorsed or licensed by Opposer, or that there is some relationship between Applicant and Opposer.

 Opposer will be damaged by the registration sought by Applicant in Class 25 and Class 28.

WHEREFORE, Opposer respectfully requests that Application Serial No. 77/311,605 be rejected in Class 25 and Class 28, that no registration be issued thereon to Applicant in Class 25 and Class 28, and that this Opposition be sustained in favor of Opposer.
