
STIPULATION

Pursuant to 37 C.F.R. Section 2.123, TBMP § 704.11, and TBMP § 705, Opposer, Deere & Company, and Applicant, Unipat Products, Virginia, LLC, hereby submit this Stipulation.

The parties stipulate that either party may submit trial testimony in affidavit form. The parties reserve the right to cross-examine any affiant. Such cross-examination may occur through telephone deposition. Any such cross-examination by Unipat of Deere's affiant(s) will occur during Unipat's trial period (August 13, 2011 - September 12, 2011); any such cross-examination by Deere of Unipat's affiant(s) will occur during Deere's rebuttal period (October 12, 2011 - October 27, 2011). If Deere presents rebuttal testimony, the parties stipulate that Unipat's cross-examination of the rebuttal witness will occur between October 27, 2011 and November 15, 2011.




