CONSENT MOTION TO SUSPEND PROCEEDINGS

Pursuant to the Order dated April 23, 2012, the proceedings were suspended as the parties are negotiating a possible resolution of this opposition. Opposer Wrangler Apparel Corp. and Applicant Hudson Clothing, LLC hereby jointly move for an additional 60-day suspension of the opposition proceeding. As requested by the Board in its Order dated April 23, 2012, the parties jointly submit the following detailed progress report in support of this request to suspend.


Subsequent to the filing of the last Consent Motion on April 17, 2012, the parties have had further communications, most recently on June 20, 2012, July 5, 2012 and July 6, 2012. There was some delay as the attorney handling the matter for Applicant had a health challenge in the middle of April 2012 and was totally out of pocket for a few weeks. Counsel for Opposer

has submitted a detailed proposal for settlement which is being reviewed by counsel for Applicant. Said proposal, if accepted, would resolve the issues in this opposition proceeding.

In view of the foregoing, the parties respectfully request that the Board grant this request to suspend the proceedings for an additional sixty (60) days so that the parties may attempt to resolve the matter. The parties are not requesting an additional suspension to delay the proceedings but are requesting same so that good faith negotiations may continue.

Counsel for Opposer Wrangler Apparel Corp. secured the express consent of Applicant Hudson Clothing, LLC for the suspension requested herein on July 6, 2012. Applicant's counsel has agreed to service of the Consent Motion by electronic mail and U.S. First Class Mail.


