1. Group Kaitu is a Limited Liability Company organized under the laws of Delaware and having its mailing address at 9702 Gayton Road, #167, Richmond, Virginia 23233, filed a Notice of Opposition against the registration of ERO SEXIN (Application No. 77/524,371) on April 30, 2010 (Proceeding No. 91194705).


2. Arne and Svenja Eilandt ("Applicants") filed an Answer to Group Kaitu's Notice of Opposition on October 6, 2010 (Group Kaitu and Applicants shall collectively be referred to as the "Parties").


