**NOTICE OF OPPOSITION**

CHF Industries, Inc., a Delaware corporation, with a business address of One Park Avenue, New York, New York 10016, believes that it will be damaged by registration of the above-identified mark, and hereby opposes the same. The required fee for filing this Notice of Opposition is submitted herewith. If any additional fees are due, please debit Account No. 03-2775.

As grounds for this opposition it is alleged that:

1. CHF Industries, Inc., including its related, affiliated, and/or predecessor companies, (collectively referred to herein as “CHF” or “Opposer”) has been and now is engaged in the manufacture and sale of, *inter alia*, home furnishings, in particular textile goods such as curtains, bedding, and bath textiles.

2. CHF is the owner of U.S. Trademark Registration No. 2,471,071 (the “‘071 Registration”), which issued on July 24, 2001, for its mark MY ROOM for the goods “pillows” in Class 20 and “textile goods, namely, pillow cases, sheets, comforters, dust ruffles, table cloths, curtains, draperies, valances, and curtain tie backs” in Class 24 (“CHF Goods”). This registration is in full force and effect as evidenced by the printout from the electronic database records of the United States Patent and Trademark Office (“PTO”) attached at Exhibit A. The ‘071 Registration is incontestable.

3. CHF is the owner of U.S. Trademark Registration No. 2,579,730 (the “‘730 Registration”), which issued on June 11, 2002, for its mark MY ROOM, TOO for the goods “pillows” in Class 20 and “textile goods, namely, pillow cases, sheets, comforters, dust ruffles, table cloths, curtains, draperies, valances and, curtain tie backs” in Class 24. This registration is in full force and effect as evidenced by the printout from the electronic database records of the United States Patent and Trademark Office (“PTO”) attached at Exhibit B. The ‘730 Registration is incontestable.

4. CHF is the owner of U.S. Trademark Registration No. 2,632,859 (the “‘859 Registration”), which issued on October 8, 2002, for its mark MY ROOM MY WAY for the goods “pillows” in Class 20 and “pillow cases, sheets, comforters, dust ruffles, table cloths, curtains, draperies, valances, and curtain tie backs” in Class 24. This registration is in full force and effect as evidenced by the printout from the electronic database records of the United States Patent and Trademark Office (“PTO”) attached at Exhibit C. The ‘859 Registration is incontestable.

5. Keeco, LLC (“Applicant”), a California limited liability company, with an address at 30736 Wiegman Road, Hayward, California 94544, filed an intent to use application on February 23, 2010 for the mark JUST US MY ROOM • MY FRIENDS • MY LIFE & Design for the goods, “bed skirts; bed sheets; comforters; coverlets; duvets; pillowcases; quilts; shams; throws” in Class 24, Application No. 77/942,514 (the “‘514 Application”).

6. On October 8, 1999, before the filing date of the ‘514 Application, the application that matured into the ‘071 Registration was filed.

7. On March 10, 2000, before the filing date of the ‘514 Application, the application that matured into the ‘730 Registration was filed.

8. On October 24, 2000, before the filing date of the ‘514 Application, the application that matured into the ‘859 Registration was filed.

9. CHF has used the MY ROOM mark of the ‘071 Registration for goods distributed and sold in the United States since at least as early as 1985; the MY ROOM, TOO mark of the ‘730 Registration since at least as early as August 15, 2000; and the MY ROOM MY WAY mark of the ‘859 Registration since at least as early as June 2000 (collectively referred to herein as the “MY ROOM Marks”). All three marks are currently in use in commerce in the United States.

10. There is no issue of priority. Upon information and belief, Applicant acquired no rights in the JUST US MY ROOM • MY FRIENDS • MY LIFE & Design mark of the ‘514 Application (“JUST US MY ROOM & Design Mark”) in the United States before CHF acquired rights in the MY ROOM Marks.

11. Upon information and belief, Applicant acquired no rights in the JUST US MY ROOM & Design Mark in the United States before February 23, 2010.

12. Upon information and belief, Applicant acquired no rights in the JUST US MY ROOM & Design Mark in the United States before October 8, 1999.

13. Upon information and belief, Applicant acquired no rights in the JUST US MY ROOM & Design Mark in the United States before 1985.

14. As a result of CHF's use of the MY ROOM Marks, and in view of CHF's advertising, promotion, and/or sale of the goods in association with the MY ROOM Marks, the MY ROOM Marks have a distinctive quality and are known to the relevant trade and public.

15. Applicant has applied to register JUST US MY ROOM & Design Mark for "bed skirts; bed sheets; comforters; coverlets; duvets; pillowcases; quilts; shams; throws." Such goods are identical to or overlapping CHF's Goods and, as such, would be distributed to the same classes of consumers and through the same channels of trade as the CHF Goods. As applied to such goods, Applicant's JUST US MY ROOM & Design Mark so resembles the MY ROOM Marks as to be likely to cause confusion, or to cause mistake, or to deceive as to the source of the goods.

16. CHF will be damaged by Applicant's registration of JUST US MY ROOM & Design Mark for the goods identified in the '514 Application as a result of the aforementioned confusion, mistake, and deception.

WHEREFORE, Opposer prays that this Opposition be sustained, and the registration sought by Applicant be refused.


