**NOTICE OF OPPOSITION**

United Van Lines, LLC (“Opposer”) will be damaged by registration of the mark UNITED STATES VAN LINES in International Class 39, as shown in U.S. Serial No. 77-901,229, filed by United States Van Lines, Inc. (“Applicant”), and therefore opposes the application. As grounds for its opposition, Opposer alleges the following:

**BACKGROUND**

- (1) Opposer is a limited liability company organized and existing under the laws of Missouri, with offices at One United Drive, Fenton, Missouri 63026.
- (2) On information and belief, Applicant is a Florida corporation, with an address of United States Van Lines, Inc. #202, Fort Lauderdale, Florida, 33309.
- (3) On information and belief, Applicant is the owner of U.S. Serial No. 77-901,229 (“Application”) for the mark UNITED STATES VAN LINES in International Class 39 for *freight transportation by truck or van* (“Applicant’s Services”).
- (4) The Application was published for opposition on August 3, 2010, so the deadline to oppose the Application is September 2, 2010. This Notice of Opposition is thus timely.
- (5) Opposer has continuously used the term UNITED as a trademark in interstate commerce in connection with transportation and storage services since at least as early as 1957, and has continuously used the phrase UNITED VAN LINES as a trade name and

trademark in interstate commerce in connection with its business and transportation and storage services. It has used UNITED VAN LINES as a trade name in interstate commerce since at least as early as 1942, and has used it as a trademark in interstate commerce since at least as early as 1957. Opposer's UNITED marks and UNITED VAN LINES trademark and trade name may be referred to collectively as the "United Van Lines Marks and Trade Name."

(6) Opposer is the owner of the following United States trademark registrations for its UNITED marks:

Said registrations are valid and in good standing. True and accurate copies of data for these registrations from the Trademark Office's TARR database, along with copies of the registration certificates, are attached to this Notice of Opposition as Exhibit 1.

(7) Information regarding and documents showing Opposer's use of the trade name and trademark UNITED VAN LINES are attached as Exhibit 2.

(8) Opposer has promoted and provided its transportation and storage services in interstate and intrastate commerce in connection with its United Van Lines Marks and Trade Name

since long prior to any alleged use by Applicant of the mark shown in the Application, and continues to do so.

(9) As a result of Opposer's use, promotion, and advertising of its United Van Lines Marks and Trade Name, the UNITED marks and the UNITED VAN LINES trademark and trade name have become well known to the trade and to the public, and have therefore acquired significant goodwill. Opposer's UNITED marks and UNITED VAN LINES trademark and trade name identify and distinguish its services from the goods and services of others, and identify the source and origin of Opposer's services to both the trade and the public.

### COUNT I

#### **(Likelihood of Confusion)**

(10) Opposer re-alleges and incorporates by reference the allegations of paragraphs 1 through 9.

(11) On information and belief, Applicant has made no use of the mark shown in the Application, nor of any word, letter or design confusingly similar thereto, as a trademark or service mark, prior to the date of first use of the United Van Lines Marks and Trade Name.

(12) Applicant's registration and use of the mark shown in the Application is likely to cause confusion in the minds of the trade and of the public that Applicant's Services emanate from or are licensed, sponsored, or otherwise authorized by Opposer, when in fact they are not.

(13) The mark shown in the Application so resembles the United Van Lines Marks and Trade Name, previously used in the United States by Opposer, and not abandoned, as to be likely, when applied to Applicant's Services, to cause confusion or to cause mistake or to deceive, and is an attempt to deceive the trade and the public and to benefit from the reputation and goodwill developed by Opposer.

(14) Opposer will be injured and damaged by the registration of the mark shown in the Application because the mark, when applied to Applicant's Services:

- (a) is likely to cause confusion, or to cause mistake, or to deceive;
- (b) falsely suggests a connection with Opposer; and
- (c) will damage Opposer's valuable goodwill in the United Van Lines Marks and Trade Name.

## COUNT II

### (Dilution)

(15) Opposer re-alleges and incorporates by reference the allegations of paragraphs 1-14.

(16) Prior to the filing date of the Application, and prior to any use by Applicant of the mark shown in the Application, Opposer's UNITED and UNITED VAN LINES marks became famous within the meaning of 15 U.S.C. § 1125.

(17) Opposer will be injured and damaged by the registration of the mark shown in the Application because the mark, when applied to Applicant's Services:

- a. will damage Opposer's valuable goodwill in its UNITED and UNITED VAN LINES marks;

- b. will impair the distinctiveness of Opposer's famous UNITED and UNITED VAN LINES marks; and

- c. will tarnish the reputation of Opposer's famous UNITED and UNITED VAN LINES marks.

ACCORDINGLY, Opposer requests that the Opposition be sustained and that registration of the mark shown in the Application be refused.

Opposer authorizes the Commissioner for Trademarks to charge the fee of \$300 to Deposit Account 20-0823 for filing this Notice of Opposition. Opposer believes that no additional fees are due; however, the Commissioner for Trademarks is authorized to debit our Account 20-0823 for any additional fees.

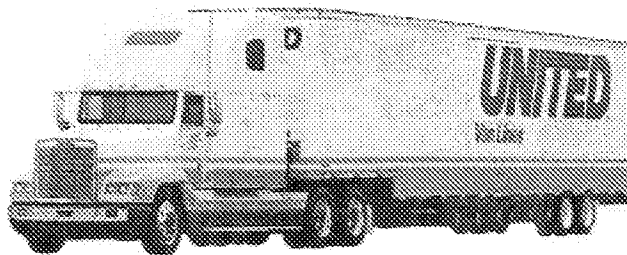

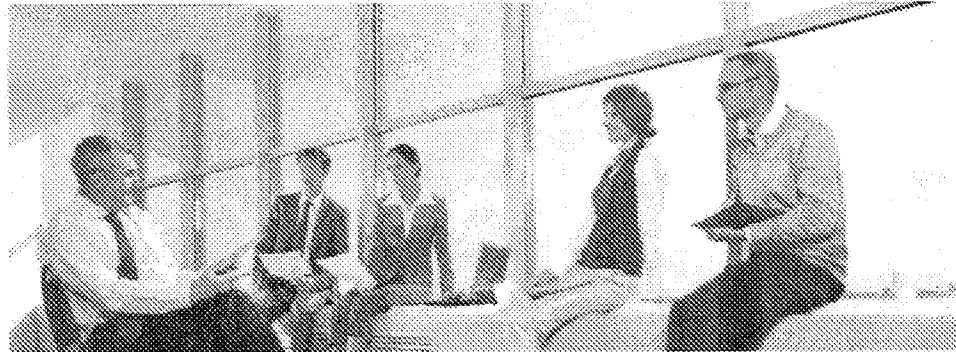
