**STIPULATED MOTION TO SUSPEND  
PENDING COMPLIANCE WITH  
SETTLEMENT TERMS**

QuorumLabs, Inc. ("Applicant"), on the one hand, and Legrand North America, Inc. and Legrand Home Systems, Inc. ("Opposers"), on the other hand, by and through their attorneys, hereby request that this Opposition proceeding be suspended while they comply with the requirements of a Coexistence Agreement ("Agreement") entered into by Applicant and Opposers, effective July 1, 2013, and await action by the Board and certain Trademark Examiners in response to filings submitted and to be submitted pursuant to that Coexistence Agreement.

The Agreement calls for Applicant to file a consented amendment to the mark that is the subject of this Opposition, Serial No. 77/864,153; Applicant complied with this requirement by submitting a Consented Motion to Amend Application to the Board on July 9, 2013. Likewise, the Agreement calls for Opposer Legrand Home Systems, Inc. ("LHS") to file an amendment in Application Serial No. 85/455,229 for the mark ON-Q; LHS submitted that amendment on July 10, 2013. When the amendments have been entered in both applications, Applicant will provide a Letter of Consent to LHS for filing in its Application Serial No. 85/455,229, the examination of which is suspended on the basis of, *inter alia*, Applicant's Application Serial No. 77/864,153. When and if the Trademark Examiner for Application Serial No. 85/455,229 accepts the Letter of Consent and withdraws citation of Applicant's Application Serial No. 77/864,153 as a potential bar to registration

of LHS's application, Opposers will file a Stipulated Dismissal with Prejudice of this Opposition proceeding.

This stipulated motion is made for the purpose of providing additional time for the actions in the preceding paragraph to be completed, and not for purposes of delay, and the parties respectfully request that it be granted.
