**JOINT STIPULATION AND/OR MOTION
TO SUSPEND PROCEEDINGS**

The parties to the above-identified opposition proceeding jointly stipulate to, and move the Trademark Trial and Appeal Board to, order this proceeding be suspended pending the final resolution or disposition of the previously consolidated Opposition Nos. 91192141 and 91193702.

The two consolidated oppositions are between the same parties and involve, inter alia, a dispute over Ms. Jacobs' right to register a mark including a "D" logo design in view of Opposer Dunhill's cited registrations including a "D" logo design. The consolidated oppositions are suspended pending resolution of Ms. Jacobs' motion to amend her Answer therein and seek cancellation of the asserted registrations.


The present opposition involves Ms. Jacobs' objection to Dunhill's application for registration of its "D" logo device alone for cigarettes based on her alleged use of her "D" logo prior to the date of first use asserted in Dunhill's application.

The parties agree that the issues in dispute in this opposition and in the consolidated oppositions are related and concern, inter alia, the issue of priority of rights. Therefore, the parties believe that disposition of the consolidated oppositions is likely to result in resolution of this opposition as well, thereby likely eliminating the need for further proceedings herein.

Accordingly, the parties agree this proceeding should be stayed and that the Board should enter an appropriate Order to that effect.


