**NOTICE OF OPPOSITION**

In the matter of U.S. Trademark Application Serial No. 77707742 ("Serial No. 77707742") for the mark CLARISSE in International Class 14, filed in the name of Promgirl, Inc. ("applicant"), which was published for opposition in the Official Gazette of June 8, 2010. Clarins Groupe S.a.r.l ("Clarins"), a corporation of Luxembourg with its principal place of business at 5, rue Eugene Ruppert, L-2453 Luxembourg, Luxembourg, believes it will be damaged by the registration of the mark in Serial No. 77707742 and hereby

opposes the same, in accordance with Section 13 of The Trademark (Lanham) Act of 1946, 15 U.S.C. §1063.

As grounds for the opposition, Clarins alleges as follows:

1. Upon information and belief, applicant is a corporation organized under the laws of Pennsylvania, with its principal address at 311 Fawn Hill Lane, Narberth, Pennsylvania 10972.

2. As evidenced by the publication of Serial No. 77707742 in the Official Gazette of June 8, 2010, applicant seeks to register CLARISSE in connection with "Jewelry, tiaras, earrings, necklaces, bracelets, brooches" in International Class 14.

3. On information and belief, applicant filed Serial No. 77707742 on April 6, 2009 based on an intent to use the mark in commerce in connection with the claimed goods.

4. Since at least 33 years prior to applicant's filing date for Serial No. 77707742, Clarins adopted and has continuously used the mark CLARINS in connection with its goods sold in the United States. Clarins also uses the trade name CLARINS in connection with its business activities.

5. Clarins is the owner of U.S. Registration No. 0935002 for the mark CLARINS for "skin cleansers in the form of lotion, cream and jelly; facial mask; lotion, cream, milk, jelly, oil used for the body, hands and feet; skin fresheners; day cream and night cream; moisture lotion, milk, cream, jelly and oil; preparations for the eyes and the throat in jelly, cream form; liquid makeup and makeup in the form of sticks, cream and milk; face powder; foam bath; lipstick; eye shadow; nail polish; rouge; cream for the legs; mascara and eyebrow pencils" in International Class 3 and "hydraulic apparatus for massage by rotary douche" in International Class 10, with a filing date of June 2, 1970.

6. Clarins also owns U.S. Registration No. 1256508 for CLARINS PARIS and Design for "skin cleaners in the form of lotion, milk, cream and jelly; facial mask; lotion, cream, milk, jelly, oil and spray to humidify, tone and relax the body, hands and feet; skin fresheners; skin day cream and night cream; skin moisture lotion, milk, cream, jelly and oil; moisturizing cream for use around the eyes and eyelids; foundation liquid makeup; liquid makeup and makeup in the form of sticks and creams; face powder; liquid and cake eyeliners; conditioning hair rinse and hair

sprays; bath oil, foam bath; dusting powder; bubble bath; lipstick; eye shadow; nail polish; rouge; milk, cream, lotion, jelly and oil to humidify, tone and relax legs; mascara and eyebrow pencils" in International Class 3, with a filing date of May 8, 1981.

7. Clarins also owns U.S. Registration No. 1574179 for CLARINS for "skin cleansers; facial masks, lotion, cream, milk, jelly, oil and spray to moisturize, tone, relax and exfoliate the body, hands and feet; skin fresheners and tonics; skin day cream and night cream; skin moisturizing lotion, milk, cream, jelly and oil; cream for use around the eyes; makeup remover; foundation makeup; nail cream; bath and shower gel and foam; bubble bath; sun tanning and self tanning gels and lotions; sunblock preparations; after-sun lotion, milk, cream, gel and oil; anti-wrinkle cream; and eau de toilette" in International Class 3, with a filing date of August 17, 1988.

8. The above-identified registrations are valid, subsisting, uncancelled and are evidence of Clarins' exclusive right to use CLARINS in commerce in connection with the goods specified in the registrations. Status and title copies from the U.S. Patent and Trademark Office's online databases are attached.

9. Clarins' use of its CLARINS mark has not been abandoned. Clarins has sold a tremendous amount of its CLARINS branded goods through retailers and online retailers throughout the United States, and its goods are associated with the CLARINS trademark and trade name among customers and the relevant trade.

10. In addition to its registered trademark rights, Clarins owns non-registered statutory and common law rights in and to its CLARINS trade name and trademark in the United States.

11. Applicant has no license, consent or permission from Clarins to use or register CLARISSE.

12. Applicant's proposed mark CLARISSE so resembles Clarins' CLARINS mark and trade name, that it is likely to cause confusion, or to cause mistake or to deceive within the meaning of Section 2(d) of The Trademark (Lanham) Act of 1946, 15 U.S.C. § 1052(d); and more particularly, applicant's mark and use thereof are likely to cause confusion in, or to cause mistake by, or to deceive the trade and purchasing public into believing that the goods in Serial No. 77707742 originate with Clarins or otherwise are authorized, licensed or sponsored by Clarins.



13. By reason of all the foregoing, Clarins will be damaged by the registration of applicant's CLARISSE mark for the goods in Serial No. 77707742, because registration of that mark would be in violation of Clarins' trademark and trade name rights.

WHEREFORE, Clarins prays that this Notice of Opposition be sustained in favor of Clarins and that Serial No. 77707742 be denied registration. Clarins submits herewith its payment of the \$300 filing fee, as required by 37 C.F.R. §2.6(a)(17).
