MOTION TO SUSPEND GRANTED

The Procter & Gamble Company's motion filed, Dec 17, 2010, to suspend this proceeding is granted. During the suspension period, the parties shall notify the Board of any change of address for either the parties or their counsel.

If an answer has not been filed, the defendant is allowed the time set forth in the motion in which to file an answer. The parties are allowed THIRTY DAYS from resumption in which to serve responses to any outstanding discovery requests.
