Opposer's consented motion to suspend filed March 27, 2012 is granted for the reasons provided in opposer's request. Proceedings herein are suspended until April 23, 2012, subject to the right of either party to request resumption at any time. See Trademark Rule 2.117(c).

In each instance, a copy of the transcript of testimony together with copies of documentary exhibits, must be served on the adverse party within thirty days after completion of the taking of testimony. Trademark Rule 2.125.

Briefs shall be filed in accordance with Trademark Rule 2.128(a) and (b). An oral hearing will be set only upon request filed as provided by Trademark Rule 2.129.
