In the matter of Serial No. 77729569 for the designed mark MAJESTICS CAR CLUB filed May 5, 2009 and published for opposition April 13, 2010 to applicant Fredrick J. Staves an individual located at P O BOX 211 RIALTO, CA.92377.Opposer Carlos Ramirez filed for the designed mark MAJESTICS Serial No. 77939515 on February 19, 2010.Currently the marks are still in litigation before the UNITED STATES TRADEMARK TRIAL AND APPEAL BOARD.

I'm writing this honorable Trademark Trial and Appeal Board in Regards to Carlos Ramirez trying to circumvent this honorable Trial and Appeal Board by serving documentation stating that he owns the MAJESTICS Trademark. Carlos Ramirez is disregarding the procedures that have been set by this honorable Trademark Trial and Appeal Board. Attached to this letter is a copy of the letter and Trademark office document that opposer Carlos Ramirez attorney served upon the president and vice president of the Compton chapter of the Majestics Car Club. Either this is a legitimate document or opposer is committing fraud. Also the first use date is 10-4-2011 and the first use in commerce date is 10-26-2011 which conflicts with the dates opposer presented to this honorable Trademark Trial and Appeal Board. The document states the Trademark is registered under International class 20 for car accessories namely plaques. Opposer Carlos Ramirez filed his opposition stating he was filing for the Majestics trademark under class 041 for social club services, namely arranging, organizing, and hosting social events, get together, and parties for club members. The serial number for the trademark on the trademark office document doesn't match the serial number filed in the consolidated opposition for the Majestics Trademark. I pray that this commissioner investigate this situation and apply the necessary sanctions that are due in this matter.

The certificate stating that Carlos Ramirez owns the MAJESTICS trademark is printed on UNITED STATES PATENT AND TRADEMARK OFFICE stationary with the Department Of Commerce seal on it. The serial no. for the opposer filed in this opposition which is 77939515 is different from the serial no. for the Majestics design mark on the Trademark Office stationary which is serial no.77939505.also the first date used in commerce and the international classes are different. Either opposer is circumventing this honorable PATENT AND TRADEMARK OFFICE by filing another application for the Majestics trademark or he is falsifying a government document. I pray that this honorable Trademark Trial and Appeal Board make the appropriate sanctions on opposer if these accusations are found to be true.
