NOTICE OF OPPOSITION

TeleTracking Technologies, Inc. (“Opposer”), organized under the laws of the State of Delaware with its principal place of business at The Times Building, 336 Fourth Avenue, Pittsburgh, PA 15222, believes it may be damaged by the registration of the mark shown in the Trademark Application Serial Number 85/059,169, and hereby opposes the same in International Class 009.

COUNT ONE – OPPOSITION OF APPLICANT’S MARKS

The grounds for opposition are as follows:

1. Opposer is a corporation organized and existing under the laws of the State of Delaware as TeleTracking Technologies, Inc., and has its principal place of business in Pennsylvania. TeleTracking Technologies, Inc., was formerly organized under the laws of the Commonwealth of Pennsylvania and was re-domiciled in Delaware in July 2008.

2. Opposer sells its products and services to customers throughout the United States and internationally, providing healthcare information.

3. Opposer has been using its TRACKING-formative trademarks, common-law and otherwise, for many years. Opposer has used its TRACKING family of marks in commerce to provide healthcare information to its customers.

4. Opposer is the owner of the valid and subsisting U.S. federal trademark registration No. 1,860,092 for BED TRACKING, registered October 25, 1994, for providing computerized patient and guest turnover information to hospitals in International Class 042. (A true and correct copy of the official USPTO registration is attached hereto and incorporated herein by reference.)

5. Said BED TRACKING registration was based on an application filed in the U.S. Patent and Trademark Office on August 17, 1992, which is a date prior to the date of the filing of Applicant's application and claimed date of first use. Opposer's first use in commerce of said BED TRACKING trademark was around June 1990, which is a date prior to the date of the filing of Applicant's application.

6. Opposer has continuously used the BED TRACKING trademark providing computerized patient information as well as related products and services from a date prior to the filing date provided in Applicant's application. Thus, this mark has priority over Applicant's application.

7. Opposer is the owner of additional trademarks, such as PREADMITTRACKING (U.S. federal trademark registration No. 3,700,390) for computer software providing patient information to hospitals in International Class 009. (A true and correct copy of the official USPTO registration is attached hereto and incorporated herein by reference.)

8. Said PREADMITTRACKING registration was based upon a first use in commerce on or about January 1, 2000, which is a date prior to the date of the filing of Applicant's application and claimed date of first use. Thus, this registration has priority over Applicant's application.

9. Opposer is also the owner of additional trademarks, such as TELETRACKING (U.S. federal trademark registration No. 3,841,921) for consulting services in the health care field in International Class 044 and for computer software for use in the health care field to enhance operational efficiencies related to patient flow, namely tracking and

management of bed turnover, patient placement and transport in International Class 009.

(A true and correct copy of the official USPTO registration is attached hereto and incorporated herein by reference.)

10. Said TELETRACKING mark was first used in commerce on or about November 30, 1999, which is a date prior to the date of the filing of Applicant's application and claimed date of first use. Thus, this registration has priority over Applicant's application.

11. Opposer is also the owner of common-law trademark TRANSPORTTRACKING for providing healthcare information to assist in workflow automation.

12. Opposer's use of the TRACKING trademarks have been valid and continuous and have not been abandoned. Said Opposer's Registration and common law usage of its TRACKING family of trademarks are symbolic of the extensive and valuable goodwill and consumer recognition built up by Opposer through substantial amounts of time, effort, and considerable sums of money, in advertising, marketing and promotion.

13. Applicant has filed trademark Application Serial No. 85/059,169, intending to have PROTRACK registered as a trademark for "Computer programs for monitoring and managing medical acute care clinical documentation, coding, and outcomes." in International Class 009.

14. Opposer's goods and services as identified in the above-listed trademark registrations and as associated with the Opposer's family of TRACKING trademarks are

identical or closely related to the goods identified in Application Serial No. 85/059,169. Upon information and belief, Opposer's goods and services and Applicant's goods are or will be offered to the same classes of customers through the same channels of trade.

15. Applicant's applied-for mark is substantially and confusingly similar to Opposer's trademarks and family of TRACKING trademarks identified above.

16. If Applicant uses the applied-for mark for the goods identified in the Application such use would be likely to cause confusion, mistake, and/or deception of the relevant trade and public.

17. If Applicant uses the applied-for mark for the goods identified in the Application, such use might convey to the relevant trade or public that Applicant's goods are in some way legitimately connected with, licensed, or approved by Opposer, when that is certainly not the case. Said source of confusion, mistake, and/or deception would be a source of damage for Opposer.

18. Since Applicant's applied-for mark is likely to cause confusion with Opposer's marks described above, Applicant's mark must be refused registration pursuant to Section 2(d) of the Lanham Act.

WHEREFORE, Opposer believes it may be damaged by the registration of the mark shown in the trademark application Serial No. 85/059,169 and that the registration of PROTRACK in International Class 009 should be rejected.

COUNT TWO –PETITION FOR PARTIAL RESTRICTION
PURSUANT TO SECTION 18

19. Paragraph 1-18, inclusive, are incorporated herein by reference as though fully set forth.

20. Without admitting that Applicant's mark may be registered as filed, Opposer seeks a restriction on the Application such that the description of services recited in that Application is restricted.

21. Upon information and belief, Applicant has not, is not, and will not use its mark in connection with software for providing operational efficiencies for the monitoring of patient placement, transport, procedure status, and management of healthcare professionals and staff in hospitals or healthcare facilities. Further, Applicant has not, is not, and will not use its mark in connection with software for use with real time location systems related to patient placement, transport, procedure status, and management of healthcare professionals, staff, equipment and supplies in hospitals or healthcare facilities.



Any likelihood of confusion caused by Applicant's mark used in connection with the goods described in the Application will be avoided if the description of goods includes the further restriction: "—said goods excluding software for providing operational efficiencies for the monitoring of patient placement, transport, procedure status, and management of healthcare professionals and staff in hospitals or healthcare facilities; also excluding software for use with real time location systems related to

patient placement, transport, procedure status, and management of healthcare professionals, staff, equipment and supplies in hospitals or healthcare facilities --“

WHEREFORE, Opposer respectfully requests that Applicant’s description of goods in the Application include the above partial restriction in International Class 009.


