Entrepreneur Media, Inc. ("EMI"), a California corporation, with a place of business located at 2445 McCabe Way, Irvine, California 92614, believes that it will be damaged by registration of the mark **ABJ ENTREPRENEUR** for "*Providing business information via the Internet*" in International Class 35, as shown in application No. 76/705112 referenced above. Therefore, in accordance with the provisions of Section 13 of the Trademark Act (15 U.S.C. § 1063), EMI hereby opposes the application of American City Business Journals Inc. ("Applicant") for the mark **ABJ ENTREPRENEUR**.

As grounds for the opposition, EMI alleges as follows:

1. EMI, and its predecessors in interest, have been and are now engaged in the business of developing, creating, distributing, marketing, advertising, and selling a wide variety of goods and services, including the publication and distribution of magazines and books, conducting seminars and other educational events, and the distribution of print and online information and advice, all concerning or of interest to businesses, business owners and would-be business owners.
2. The mark **ENTREPRENEUR** has at all times been used in, on or with the aforementioned goods and services.
3. EMI has been using the **ENTREPRENEUR** mark in commerce for over 30 years, having first adopted the mark **ENTREPRENEUR** for magazines at least as early as May 2, 1978.
4. EMI owns a family of marks registered with the U.S. Patent and Trademark Office, which consist of or include the **ENTREPRENEUR** mark:

5. EMI's above registrations are valid, unrevoked, uncancelled, and in full force and effect. EMI owns these registrations and the trademarks shown thereby and all the business and goodwill connected with said marks in the United States. Two copies of the certificates of registration issued in connection with each trademark registration referenced above, along with status printouts from the U.S. Patent and Trademark Office, are attached as exhibits to this Notice.

6. As noted in the table above, EMI adopted and used the mark **ENTREPRENEUR** and related marks in connection with a wide variety of goods and services, including providing information on a website on the internet, prior to October 28, 2010, the filing date of Applicant's trademark application, and prior to April 23, 2010, Applicant's claimed first use date.

7. EMI's **ENTREPRENEUR** mark is strong, well known, and of great value to EMI. In the mind of the trade and of the public, EMI's **ENTREPRENEUR** mark identifies and designates EMI's goods and services and distinguishes them from the goods and services of

others.

8. The United States District Court for the Central District of California has determined that EMI's mark **ENTREPRENEUR** has become and is a strong mark in the industry as a result of extensive advertising and public recognition over the past 25 years. *Entrepreneur Media, Inc. v. Smith*, No. CV 98-3607 FMC (CTx), 2004 U.S. Dist. LEXIS 24078 (C.D. Cal. June 23, 2004). These findings were affirmed by the Ninth Circuit Court of Appeals. *Entrepreneur Media, Inc. v. Smith*, 101 Fed. Appx. 212 (9th Cir. 2004).

9. By the application herein opposed, Applicant seeks to register **ABJ ENTREPRENEUR** for services in Class 35.

10. Applicant's mark so resembles EMI's previously used and registered **ENTREPRENEUR** mark and is therefore likely, when used in connection with Applicant's services, to cause confusion, mistake, or deception with consequent injury to EMI and the public.

11. EMI would be damaged, and its superior rights violated, by the registration of Applicant's mark if granted, in that: (i) this registration would support and assist Applicant in the confusing, misleading, and deceptive use of Applicant's mark ; and (ii) this registration would give Applicant statutory rights and protections to which Applicant is not entitled.

WHEREFORE, EMI believes that it will be damaged by the registration of Applicant's mark and prays that it be denied.


