**WITHDRAWAL WITH PREJUDICE**

Keen, Inc. (“Opposer”) respectfully requests that the above-referenced proceeding be withdrawn with prejudice. In support of this request, Opposer states:

1. On June 3, 2011, Opposer filed a Petition for Opposition (“Petition”) against U.S. App. No. 85/077,738, alleging prior use, common law rights and likelihood of confusion with Opposer’s mark, as described in U.S. App. No. 85/077,738. The Petition was assigned No. 91200124 by the Trademark Trial and Appeal Board.

2. Opposer and Applicant entered into a coexistence agreement (“Agreement”) on July 5, 2013. Under the terms of the Agreement, both parties are required to work together to avoid confusion in the marketplace and to provide letters of consent as necessary. In addition, both parties are required to withdraw any oppositions to current applications that comply with the terms of the Agreement.

3. The application for U.S. App. No. 85/077,738 is compliant with the terms of the Agreement.

Therefore, Opposer requests that TTAB Opposition Proceeding No. 91200124 be withdrawn with prejudice.
