NOTICE OF OPPOSITION

Itaú Unibanco S.A., a corporation organized under the laws of Brazil, with its principal place of business at Praca Alfredo Egydio de Souza Aranha 100, Torre Olavo Setubal, Sao Paulo, Brazil (“Opposer”), opposes registration of the above-identified application by Italpromotions, Inc., a corporation organized under the laws of Florida, with its principal place of business at 1111 Kane Concourse, Suite 410, Bar Harbor Islands, Florida 33154 (“Applicant”).

Opposer believes that it will be damaged by registration of the mark shown in the above-identified application, and hereby opposes same in accordance with Trademark Act § 13, 15 U.S. C. §1063 and Trademark Rule 2.101, 37 C.F.R. §2.101. The grounds for opposition are

as follows:

1. Opposer provides a variety of banking and financial services, including, among others, currency exchange; loan financing; investment services, namely, asset acquisition, consultation and development services; electronic payment, namely, electronic processing and transmission of bill payment data; financial advisory services; commercial lending services; providing lines of credit for commercial purposes; providing loan guarantees; cash management services; trade services, namely, import and export collection transactions and document processing for imports and exports; investment banking services; investment of funds for others; investment advisory services; equity capital market services, namely, advising on and providing primary and secondary public offerings, initial public offerings, share tender offers; debt capital market services, namely, advising on and providing local and international fixed income instruments.

2. Opposer is the owner of Registration No. 1,198,257 for the mark ITAU for “banking services” in International Class 036, filed July 1, 1981 and registered on June 15, 1982, which has become incontestable. A copy of the TARR printout on this mark is attached hereto as Exhibit A.

3. Opposer is the owner of Registration No. 2,677,383 for the mark ITAU & Design for “banking services” in International Class 036, filed on February 7, 2002 and registered on January 21, 2003, which has become incontestable. Opposer’s ITAU & Design mark has been in use in commerce with these services since at least as early as February 21, 1980. A copy of the TARR printout on this mark is attached hereto as Exhibit B.

4. Opposer is the owner of Registration No. 3,808,596 for ITAÚ & Design in color for “banking services; currency exchange; loan financing; investment services, namely, asset acquisition, consultation and development services; electronic payment, namely, electronic processing and transmission of bill payment data; financial advisory services; commercial lending services; providing lines of credit for commercial purposes; providing loan guarantees; cash management services; trade services, namely, import and export collection transactions and document processing for imports and exports; investment banking services; investment of funds for others; investment advisory services; equity capital market services, namely, advising on and providing primary and secondary public offerings, initial public offerings, share tender offers; debt capital market services, namely, advising on and providing local and international fixed income instruments” in International Class 036. This application was filed on May 19, 2006 and registered on June 22, 2010. As reflected in the TARR printout on this mark attached hereto as Exhibit C, this mark has been in use since at least as early as 2003.

5. Opposer is the owner of Registration No. 3,812,243 for the mark ITAÚ & Design for “banking services; currency exchange; loan financing; investment services, namely, asset acquisition, consultation and development services; electronic payment, namely, electronic processing and transmission of bill payment data; financial advisory services; commercial lending services; providing lines of credit for commercial purposes; providing loan guarantees; cash management services; trade services, namely, import and export collection transactions and document processing for imports and exports; investment banking services; investment of funds for others; investment advisory services; equity capital market services, namely, advising on and

providing primary and secondary public offerings, initial public offerings, share tender offers; debt capital market services, namely, advising on and providing local and international fixed income instruments” in International Class 036. This application for this mark was filed on May 26, 2006 and the mark was registered on June 29, 2010. As reflected in the TARR printout on this mark attached hereto as Exhibit D, this mark has been in use on the services since at least as early as 2003. The marks referenced in paragraphs 2-5 above are referred to collectively herein as the “ITAU Marks.”

APPLICANT’S MARK

6. Notwithstanding Opposer’s prior rights in the ITAU Marks in the United States, on July 2, 2010, Applicant filed an application to register the mark IC ITALCAPITAL & Design mark in color (the “ITALCAPITAL Mark”) for “securities brokerage” in International Class 036. The application was assigned Serial No. 85/077322 and alleges use in commerce since May 3, 2010. The application for the ITALCAPITAL Mark was published for opposition on April 26, 2011 and is currently pending on a Section 1(a) basis.

LIKELIHOOD OF CONFUSION

7. Pursuant to Trademark Act § 2(d), 15 U.S. C. § 1052(d), Applicant’s ITALCAPITAL Mark is confusingly similar to Opposer’s ITAU Marks and is likely to create confusion, mistake or deception as to the source, sponsorship or affiliation of Applicant’s services, all to the damage of Opposer for the following reasons, among others:

8. Applicant's ITALCAPITAL Mark is substantially similar in sight, sound and appearance to Opposer's ITAU Marks so as to cause a likelihood of confusion or deception to the relevant users and consuming public.

9. Applicant is not affiliated with Opposer, and Opposer has not authorized Applicant to use or register the ITALCAPITAL Mark.

10. The ITAU Marks are highly distinctive and therefore strong marks.

11. On information and belief, the parties' respective marks are used in connection with similar services in International Class 036.

12. On information and belief, Applicant's services under the ITALCAPITAL Mark are likely to be offered to the same persons to whom Opposer offers its services under the ITAU Marks.

13. On information and belief, the channels of trade for the Opposer's and Applicant's services are likely to overlap.

14. There is no issue with respect to priority. Opposer's rights in the ITAU Marks, including their filing, use, constructive use and/or registration dates, are prior in time and otherwise superior to any rights that Applicant may claim in the ITALCAPITAL Mark.

USE IN COMMERCE

15. On information and belief, notwithstanding the representations in its application for the ITALCAPITAL Mark and subsequent submissions to the United States Patent and Trademark Office, Applicant has never made a bona fide use of the ITALCAPITAL Mark in

commerce in the United States, as required under Trademark Act § 1, 15 U.S.C. § 1051 and defined in Trademark Act § 45, 15 U.S.C. §1127.

OWNERSHIP

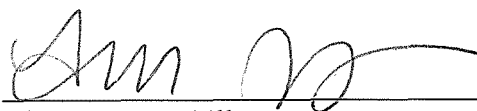
16. On information and belief, Applicant was not the owner of the ITALCAPITAL Mark at the time the underlying application was filed and the application was void *ab initio* under Trademark Act § 1, 15 U.S.C. § 1051 because the Application was not filed by the true owner of the mark.

WHEREFORE, Opposer believes it will be damaged by the registration of the ITALCAPITAL Mark and therefore requests that registration of Applicant's ITALCAPITAL Mark be refused and that the instant Opposition be sustained.

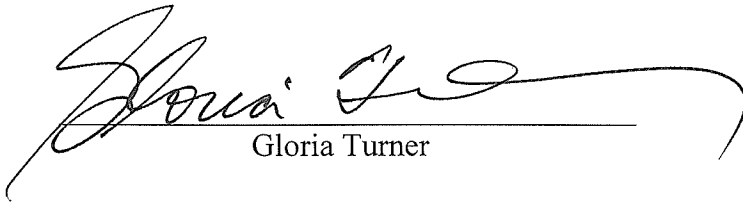
