**STIPULATED MOTION TO SUSPEND
PENDING OUTCOME OF ANOTHER PROCEEDING**

Pursuant to T.T.A.B. §5120.02 and C.F.R. §2.117(a), Opposer and Applicant hereby request that the Board suspend this Opposition No. 91202256 (the “Opposition”) pending the outcome of the case *Troy Landry Prods., LLC. v. Halpern Import Co. et al*, No. 6:12-CV-0004 (W.D. La. filed Jan. 3, 2012) (the “Landry Lawsuit”).

At least one of the members of plaintiff in the Landry Lawsuit also is a member of Applicant. The defendants in the Landry Lawsuit are licensees of Opposer. The Landry Lawsuit has issues in common with the Opposition and the outcome of the Landry Lawsuit likely will have a bearing on the Opposition.

For the foregoing reasons, both Applicant and Opposer request that the Board suspend the Opposition until final determination of the Landry Lawsuit. Counsel for Applicant agreed to this Stipulated Motion to Dismiss via an email on February 12, 2012.
