Plaintiff's Pretrial Disclosures Due	195 days after resumption of proceedings

Plaintiff's 30-day Trial Period Ends	240 days after resumption of proceedings
Defendant's Pretrial Disclosures Due	255 days after resumption of proceedings
Defendant's 30-day Trial Period Ends	298 days after resumption of proceedings
Plaintiff's Rebuttal Disclosures Due	313 days after resumption of proceedings
Plaintiff's 15-day Rebuttal Period Ends	343 days after resumption of proceedings
