MOTION ON CONSENT TO AMEND APPLICATION AND, IF ACCEPTED, TO WITHDRAW THE OPPOSITION ON CONSENT

Pursuant to Rule 2.133 of the Trademark Rules of Practice, Applicant respectfully requests that the above-captioned application be amended by:

1. adding the bolded language "; all the foregoing relating to a university and/or to collegiate sports" to the end of the description of goods in Class 25, which should now read:

T-SHIRTS, SWEAT SHIRTS, CAPS, AND SWEAT PANTS; ALL THE FOREGOING RELATING TO A UNIVERSITY AND/OR TO COLLEGIATE SPORTS in International Class 25

2. adding the bolded word "collegiate" before the words "athletic," "events," "tournaments," and "exhibitions," and adding the bolded language "; all the foregoing

in a university and/or collegiate sports context" to the end of the description of services in Class 41, which should now read:

ENTERTAINMENT AND EDUCATIONAL SERVICES, NAMELY, PROVIDING COURSES OF INSTRUCTION AT THE UNIVERSITY LEVEL; ARRANGING AND CONDUCTING COLLEGIATE ATHLETIC COMPETITIONS, COLLEGIATE EVENTS, COLLEGIATE TOURNAMENTS, AND COLLEGIATE EXHIBITIONS; ALL THE FOREGOING IN A UNIVERSITY AND /OR COLLEGIATE SPORTS CONTEXT in International Class 41.

It is respectfully submitted that these amendments do not require republication as the amendments of the descriptions of goods and services narrow rather than broaden the scope of the application.

These amendments are made pursuant to an Agreement between Applicant and Opposer, who has consented to these amendments. If the amendments are approved by the Board, Opposer, with Applicant's consent, requests that the opposition be withdrawn without prejudice.
