MOTION TO AMEND APPLICATION

Applicant, Rockler Companies, Inc. ("Applicant") respectfully moves to amend trademark application Serial No. 85/206327 for the trademark, DUSTRIGHT VORTEX be amended as follows:

1. Applicant respectfully requests that the identification of goods be deleted in entirety and replaced with the following identification to restrict the field of use:

International Class 007: vacuum cleaners and their components, vacuum cleaner attachment consisting of a container for holding the debris for workshop use.

It is respectfully submitted that this amendment does not require republication as the amendment of the description of goods narrows, rather than broadens, the scope of the application.

2. Applicant respectfully requests that the trademark be amended to include the following disclaimer:

Apart from common law and other trademark rights, and for purposes of Federal registration only, no claim is made to the exclusive right to use VORTEX apart from the mark as shown.

These amendments are to narrow the issues in the pending opposition filed by Opposer, Oneida Air Systems, Incorporated (Opposer). An Answer is filed herewith. Opposer is in no way prejudiced by this amendment.
