NOTICE OF OPPOSITION

Opposer, Maverick Capital Ltd., a limited partnership existing under the laws of the state of Texas and having an address of 300 Crescent Court, Suite 1850, Dallas, TX 75201, believing it will be damaged by registration of MAVERICK FUNDING CORP. & Design as a trademark in International Class 36 for “financial services, namely, direct mortgage lending” as shown in Serial No. 85348072, hereby opposes same.

As grounds for opposition, Maverick Capital alleges as follows:

1. Applicant, Maverick Funding Corp. seeks registration of MAVERICK FUNDING CORP. & Design (“the Subject Mark”) (shown below), with “FUNDING CORP.” disclaimed, as a trademark in International Class 36 for “financial services, namely, direct mortgage lending” (“the Subject Financial Services”):



2. Applicant filed Application Serial No. 85348072 on June 16, 2011, claiming that the mark has been in use for the Subject Financial Services since July 2007.
3. Maverick Capital is the owner of a family of “MAVERICK” trademarks for a variety of financial services (collectively the “MAVERICK Marks”), including the following registered marks:

4. Maverick Capital, its licensees, and/or its predecessors-in-interest, have used the MAVERICK Marks in interstate commerce in connection with financial services since well before the date of first use claimed in Application Serial No. 85348072.

5. Maverick Capital, its licensees, and/or its predecessors-in-interest, have invested significant resources advertising and promoting services sold under the MAVERICK Marks, and has used the marks in connection with the provision of many millions of dollars worth of services, including the management of hedge funds totaling approximately \$10 billion in assets. As such, consumers and others view Maverick Capital as the origin of financial services sold or provided under the “MAVERICK” mark. The MAVERICK family of marks acquired distinctiveness, fame, and renown well before Applicant’s claimed date of first use.

6. Upon information and belief, Applicant will offer the Subject Financial Services under the MAVERICK FUNDING CORP. & Design mark to a variety of consumers, many of whom are already likely to be familiar with financial services offered or provided by Maverick Capital in connection with one or more of its MAVERICK Marks.
7. As may be seen by comparing the marks, Applicant's MAVERICK FUNDING CORP. & Design mark appropriates Maverick Capital's MAVERICK mark in its entirety. The addition by Applicant of the "FUNDING CORP." designation (which, regardless, Applicant has disclaimed) to the MAVERICK mark is unlikely to dispel confusion and, in fact, will likely heighten confusion as many consumers are apt to believe that "MAVERICK FUNDING CORP." is merely yet another MAVERICK-branded financial service offered by Maverick Capital.
8. Applicant's proposed use of MAVERICK FUNDING CORP. & Design in connection with the Subject Financial Services thus is likely to cause consumers mistakenly to believe that such services are somehow related to Maverick Capital or to one or more of the family of MAVERICK Marks, or that such services originate from, or are sponsored or approved by, Maverick Capital (or vice versa). This confusion and mistake is likely to cause injury to Maverick Capital.
9. If Applicant is awarded a registration for MAVERICK FUNDING CORP. & Design in connection with the Subject Financial Services as requested through

Serial No. 85348072, it would be entitled to the statutory presumptions flowing from such a registration, all to the injury of Maverick Capital.

10. Concerned about the potential for confusion and for harm, Maverick Capital timely filed this Notice of Opposition within the prescribed statutory period.
11. Maverick Capital has not given Applicant permission or approval to use the mark MAVERICK FUNDING CORP. & Design, or to incorporate the MAVERICK designation into any mark for use with financial or related services.
12. Accordingly, registration for the mark applied for through Serial No. 85348072 should be refused under the provisions of Section 2(d) of the Trademark Act.

WHEREFORE, Opposer, Maverick Capital, Ltd., prays that Application Serial No. 85348072 be rejected, that no registration be issued to Applicant, and that this opposition be sustained in favor of Maverick Capital.
