As grounds for opposition, it is alleged:

- 1. Opposer is a company that offers lenses for cameras incorporated in mobile electronic devices including mobile phones, and carrying cases for electronic devices including mobile phones, in connection with its OLLOCLIP mark.
- 2. Opposer is the owner of and relies on U.S. Trademark Registration No. 4137064 for the mark OLLOCLIP for "Lenses for cameras; lenses for cameras incorporated in mobile electronic devices" in International Class 9 ("OLLOCLIP Registration"). Attached as Exhibit A is a true and correct copy of the printout from the electronic database records of the United States Patent and Trademark Office ("PTO") showing the current status and title of the OLLOCLIP Registration, as well as a true and correct copy of the registration certificate for the OLLOCLIP Registration. The OLLOCLIP Registration's filing date is June 21, 2011. Opposer's date if first use of the OLLOCLIP mark in connection with lenses was at least as early as July 2011. Opposer's filing date and first use date for the OLLOCLIP mark in connection with lenses are prior to the November 9, 2011 filing date for Applicant's OLLO Applications. Opposer's OLLOCLIP mark passed to registration on the Principal Register on May 1, 2012. Pursuant to Section 7 of the Trademark Act, 15 U.S.C. § 1057(c), Opposer's trademark rights to the OLLOCLIP mark in connection with lenses predate any alleged trademark rights Applicant may claim to the OLLO mark subject of Applicant's OLLO Applications.
- 3. Opposer's U.S. Registration No. 4137064 is valid, subsisting, unrevoked and uncancelled; as such it constitutes *prima facie* evidence of the validity of Opposer's registered OLLOCLIP mark and of the registration thereof, and of Opposer's ownership of the OLLOCLIP mark shown therein. Opposer's OLLOCLIP Registration also constitutes notice to Applicant of Opposer's claim of ownership of the OLLOCLIP mark shown therein as provided in Sections 7(b), 22 and 33(a) of the Trademark Act, 15 U.S.C. §§ 1057(b), 1072 and 1115.

- 4. Opposer is the owner of and also relies on U.S. Serial No. 85/351810 for the mark OLLOCLIP for "Carrying cases for mobile electronic devices" in International Class 9 ("OLLOCLIP Application"). Attached as Exhibit B is a true and correct copy of the printout from the electronic database records of the PTO showing the current status and title of the OLLOCLIP Application. The OLLOCLIP Application's filing date is June 21, 2011. The OLLOCLIP Application predates the November 9, 2011 filing date for Applicant's OLLO Applications.
- 5. Since at least before the filing date of Applicant's OLLO Applications, Opposer has continuously used and promoted the OLLOCLIP mark in interstate commerce in connection with Opposer's goods. By virtue of Opposer's continuous and substantial use, the OLLOCLIP mark has become an identifier of Opposer and its goods, and distinguishes Opposer's goods from the goods of others. As a result, Opposer has built up, at great expense and effort, a significant amount of valuable goodwill in the OLLOCLIP mark.
- 6. In addition to the protection afforded Opposer by its federal trademark registration and application, Opposer has extensive common law rights in the OLLOCLIP mark throughout the United States.
- 7. Applicant's OLLO Applications were filed on November 9, 2011, and are based on Applicant's intent to use the mark. Opposer's rights in its OLLOCLIP mark are prior and superior to Applicant's rights in the OLLO mark.
- 8. Based on Applicant's OLLO Applications, Applicant intends to use the OLLO mark in connection with several goods and services, including carrying cases for mobile phones, accessories for mobile phones, mobile phones, PDAs, wireless hand-held devices, television broadcasting to handheld mobile devices, and providing satellite and terrestrial services for

mobile users. The goods and services listed in Applicant's OLLO Applications are identical or related to the goods in connection with which Opposer uses its OLLOCLIP mark.

- 9. Opposer will be damaged by registration of Applicant's OLLO mark subject of Applicant's OLLO Applications, in that the OLLO mark so resembles Opposer's OLLOCLIP mark registered in the PTO, and in which Opposer owns common law trademark rights, as to be likely, when used on or in connection with the goods and services identified in Applicant's OLLO Applications, as to cause confusion, or to cause mistake or to deceive within the meaning of Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).
- 10. In view of Opposer's prior rights in its OLLOCLIP mark, Applicant is not entitled to registration of the OLLO mark, subject of Applicant's OLLO Applications, pursuant to Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).
