STIPULATION TO SUSPEND FOR SETTLEMENT DISCUSSIONS

WHEREAS, Anchor Brewing Company, LLC (“Opposer”) has filed the captioned opposition proceedings;

WHEREAS, Mountain Shippers, LLC (“Applicant”) has filed its answer to the opposition;

WHEREAS, Applicant and Opposer have conducted the required discovery conference; and

WHEREAS, Applicant and Opposer are now engaged in substantive settlement discussions and wish to stay further proceedings for a period of three months to complete those negotiations;
