**MOTION ON CONSENT TO AMEND APPLICATION
AND, IF ACCEPTED, TO DISMISS OPP. NO. 91209607 WITHOUT PREJUDICE**

Pursuant to Rule 2.133(a) of the Trademark Rules of Practice, Applicant, with Opposer's consent, respectfully requests that the above identified application be amended to include the following language in place of the current identification of goods in International Classes 18 and 25 on the Application Serial No. 85/637,087: "*hiking backpacks; canes and walking sticks; hiking bags; hiking poles; hiking rucksacks; hiking sticks; hunting bags; mountaineering sticks; sportsman's hunting bags; walking sticks in International Class 18; and bandanas; camouflage jackets; climbing boots; fishermen's jackets; fishing shirts; fishing vests; fishing waders; hiking boots; hunting jackets; hunting pants; hunting shirts; hunting vests; leg shielding device, attachable to and detachable from a person's pants, comprised of padding to shield the legs from flying debris when mowing with a string trimmer; light-reflecting jackets; mountaineering boots; mountaineering shoes; padded jackets; and trekking boots* in International Class 25.

It is respectfully submitted that this amendment does not require republication because the amendment to the description of goods narrows rather than broadens the scope of the registration.

If this amendment is approved by the Board, Opposer, with Applicant's consent,
hereby requests that the opposition be dismissed without prejudice.


