
REPLY TO OPPOSITION TO MOTION TO DIVIDE APPLICATION

Shipcom's Opposition to Applicant's Motion To Divide states that Shipcom only opposes the division of Classes 9 and 35 of the instant application. Therefore, as Shipcom does not oppose the division of Classes 36 and 44 in the instant application, Applicant respectfully requests that Classes 36 and 44 be divided from the instant application immediately.

With respect to the division of Class 35 from the instant application, Applicant filed a Motion to Dismiss concurrent with the filing of this Reply that requests the dismissal of the Opposition against Class 35. Therefore, Applicant requests that a ruling on whether Class 35 be divided from the instant application be stayed until there is a ruling on the Motion to Dismiss. 
