NOTICE OF OPPOSITION

In the matter of the application for registration of the following trademark:



("Applicant's Mark") for "telecommunications services, namely, providing e-mail notification alerts via the internet" ("Applicant's Services"), Serial No. 85631068, filed May 21, 2012, by Michael A. Siciliano ("Applicant"), Dowco, Inc. ("Dowco"), a Wisconsin corporation located at 4230 Clipper Drive, Manitowoc, Wisconsin 54220, believes it will be damaged by registration of Applicant's Mark and opposes the same on these grounds:

1. Dowco adopted the GUARDIAN COVERS mark in 1984 for motorcycle covers and has used the GUARDIAN COVERS mark continuously for these goods since 1984. In 2004, Dowco expanded the use of its GUARDIAN brand beyond motorcycle covers to include vehicle covers for all-terrain vehicles, boats, snowmobiles and personal watercraft. Dowco also began selling motorcycle covers under the GUARDIAN WEATHERALL mark in 2004.

2. Dowco owns the following federal trademark registrations for its GUARDIAN marks, which have been in use since long prior to Applicant’s filing date, and attaches status printouts of these registrations as **Exhibit A:**

The registered marks listed above are hereafter collectively referred to as the “GUARDIAN Marks.”

3. The GUARDIAN COVERS and GUARDIAN registrations have become incontestable and constitute conclusive evidence of the validity of the marks, Dowco’s ownership thereof, and of Dowco’s exclusive right to use the registered marks in connection with the goods identified in the registrations (15 U.S.C. § 1115(b)).

4. The GUARDIAN WEATHERALL registration constitutes prima facie evidence of the validity of the mark, Dowco’s ownership thereof, and of Dowco’s exclusive right to use the registered mark in connection with the goods identified in the registration (15 U.S.C. § 1115(a)).

5. Dowco has priority of use over Applicant.

6. Dowco has expended a great deal of time, effort and money in the promotion and advertisement of the vehicle covers sold under the GUARDIAN Marks.

7. As a result of Dowco's continuous advertising and distribution of vehicle covers under one or more of the GUARDIAN Marks since 1984, Dowco has acquired valuable goodwill in the GUARDIAN Marks and the GUARDIAN Marks indicate that Dowco is the source of the goods.

8. Notwithstanding Dowco's prior and continuous use of the GUARDIAN Marks for vehicle covers, Applicant filed for Applicant's Mark in May 2012 for "fitted covers for boats and marine vehicles; fitted covers for vehicles; unfitted covers for boats and marine vehicles; unfitted vehicle covers; [and] telecommunication services, namely, providing e-mail notification alerts via the internet."

9. On September 11, 2012, the USPTO issued an Office Action that refused registration of Applicant's Mark for vehicle covers as confusingly similar to Dowco's GUARDIAN Marks. In response to the Office Action, Applicant deleted vehicle covers from the description of goods and services.

10. Three days after the USPTO refused registration of Applicant's Mark for vehicle covers, Applicant contacted Dowco and inquired about Dowco making an investment in Applicant's business. In that communication, Applicant admitted his awareness of the GUARDIAN Marks for vehicle covers and that a Google search for "Guardian Covers" led him to Dowco.

11. After receiving Applicant's e-mail, Dowco discovered that Applicant owned and used the www.hailguardian.com domain name for a website using Applicant's Mark to promote a vehicle hail protection system consisting of mobile alert services and protective vehicle covers.

12. Dowco immediately responded to the Applicant's e-mail inquiry by informing Applicant that Dowco did not authorized Applicant to use Dowco's GUARDIAN Marks and that any use of Dowco's GUARDIAN Marks, or confusingly similar marks incorporating the term GUARDIAN, would create confusion about the source of Applicant's goods and services.

13. Applicant uses Applicant's Mark on a website that drives traffic to another website that promotes Applicant's vehicle covers. The www.hailguardian.com website features Applicant's Mark and the website redirects to Applicant's website at www.hailstormproducts.com, which promotes vehicle covers and hail alert services offered under Applicant's "Hail Protector" and "Hail Storm Products" brands. Printouts from the www.hailguardian.com and www.hailstormproducts.com websites are attached as **Exhibit B**.

14. The design portion of Applicant's Mark is identical to the design portions of the "Hail Protector" and "Hail Storm Products" logo marks that appear on Applicant's www.hailstormproducts.com website. The similarity between Applicant's marks appearing on his various websites creates a connection between Applicant's Mark, Applicant's Services and vehicle covers, which Applicant sells under the "Hail Protector" and "Hail Storm Products" logo marks. *See Exhibit B.*

15. Dowco's vehicle covers sold under the GUARDIAN Marks and the services that Applicant intends to offer under Applicant's Mark are closely related to one another because Applicant's Services are designed to alert consumers about hail storms so that customers can

then use Applicant's vehicle covers. Applicant's marketing of its vehicle covers under logo marks highly similar to Applicant's Mark confirms the close relationship between Applicant's Services and vehicle covers.

16. Applicant's original application for Applicant's Mark and his e-mail to Dowco express Applicant's intent to sell vehicle covers for motorcycles and boats, such that Applicant's Services are also likely to be used in connection with vehicle covers for motorcycles and boats. Accordingly, the parties' goods and services are likely to be offered to the same customers through the same or similar channels of trade.

17. The "HAIL" portion of Applicant's Mark is descriptive, such that Applicant's Mark and Dowco's GUARDIAN Marks are nearly identical in sound, meaning and commercial impression when used in connection with vehicle covers and a hail alert service marketed in connection with protective vehicle covers.

18. Applicant agreed to a disclaimer of "HAIL" in Applicant's Mark and has thus acquiesced to the descriptiveness of the term "HAIL" as used in connection with Applicant's Services.

19. Applicant also uses an e-mail address that incorporates the HAIL GUARDIAN portion of Applicant's Mark, such that consumers contacting Applicant about vehicle covers will believe there is a connection between Applicant Services offered under Applicant's Mark and vehicle covers.

20. Consumers for Applicant's Services sold under Applicant's Mark are likely to be confused, mistaken and deceived as to whether Applicant's Services originate with or are sponsored, authorized, or licensed by Dowco.

21. Applicant is not entitled to the registration sought, and said registration, if allowed, would be a source of injury and damage to Dowco.

22. Applicant does not have permission from Dowco to use or register Applicant's Mark.

WHEREFORE, Dowco requests that the opposition be sustained and that the registration sought by Applicant be refused.

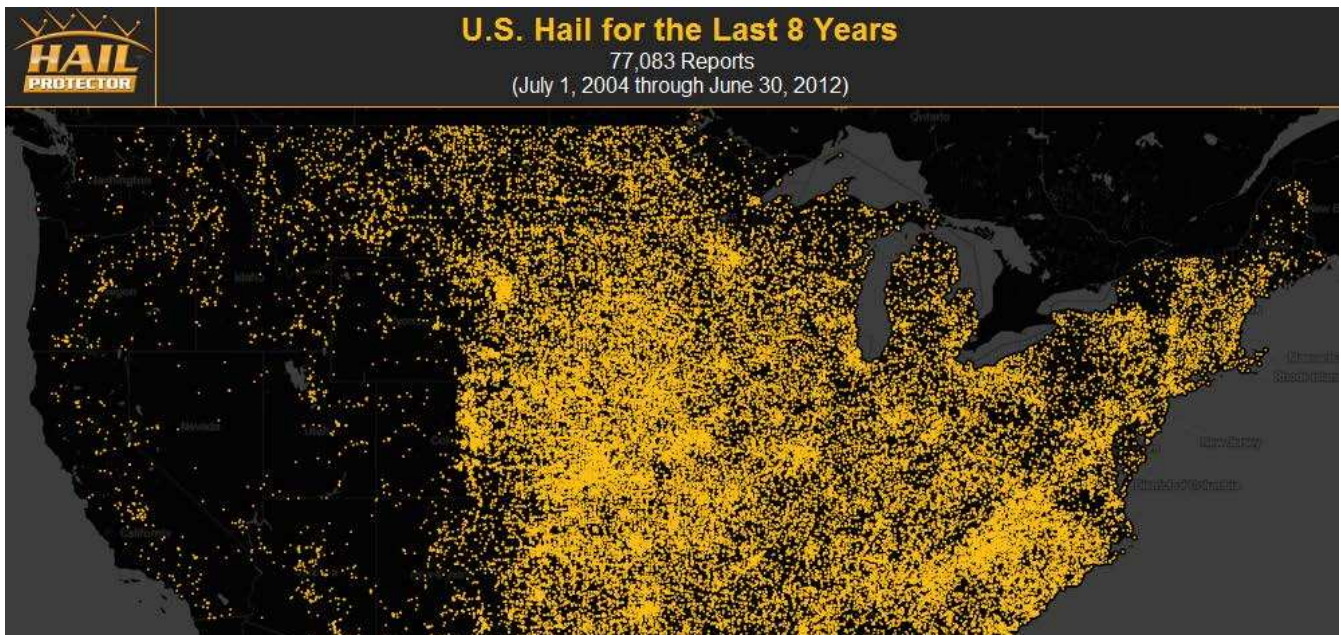
