**APPLICANT'S AMENDMENT WITH CONSENT  
AND STIPULATED WITHDRAWAL OF OPPOSITION**

Sir:

1. Amendment. The Applicant in the above referenced matter, with the consent of the Opposer as indicated below, hereby amends the description of goods in the applicant's above-referenced application, Serial No. 79/122,882 (the "Application"), to read as follows (deletions by strike-out, additions underlined):

International Class 014: Delete Class 14 from the Application in its entirety.

International Class 018: No changes.

International Class 025: Delete the wording "fur stoles" from Class 25 of the Application, with the revised description to read as follows: "Jackets; suits; skirts; trousers; pants; dresses; wedding dresses; coats; sweaters; shirts; nightwear; underwear; swimwear; swimming caps; Japanese traditional clothing, namely, kimonos; sleep masks; aprons for wear; collar protectors for wear; socks and stockings; puttees and gaiters; shawls; scarves; Japanese style socks (tabi); Japanese style socks covers

(tabi covers); gloves and mittens for wear; neckties; neckerchieves; bandanas; mufflers for wear; ear muffs as clothing; nightcaps; headgear, namely, hats and caps; garters; sock suspenders; suspenders; waistbands; belts for clothing; leather shoes; sandals; beach shoes; sneakers; slippers; boots; masquerade costumes."

As the amendment narrows the description of goods, and does not require reclassification, entry is proper and respectfully requested.

2. Withdrawal of Opposition. The above amendment is being presented with the consent of Opposer so as to resolve the pending Opposition by agreement.

Subject to approval of this amendment to the Application by the Trademark Trial and Appeal Board, the parties hereby stipulate to the withdrawal of the above-referenced opposition (the "Opposition") without prejudice.

If this amendment to the Application is not acceptable to the Board in its entirety, the stipulated withdrawal herein shall be void and of no effect, the Opposition shall continue on its current case schedule, and the parties will attempt to reach an agreement regarding a revised goods identification that is acceptable to the Board and submit it in a new filing.
