**NOTICE OF OPPOSITION**

Opposers Facton Ltd. and G-Star Raw C.V. (together, “G-Star”) believe that they would be damaged by the issuance of a registration for the trademark RAW MASCARA, as applied for in Application Serial No. 85/645,677, and therefore oppose the same. As grounds for their opposition, G-Star, by their attorneys Fross Zelnick Lehrman & Zissu, P.C., allege as follows:

1. G-Star is an international clothing and lifestyle company headquartered in the Netherlands and known for its edgy, industrial design concept. G-Star’s goods include, but are not limited to, an extensive clothing line, including various apparel, accessories and bags.
2. For many years, G-Star has used in connection with its business, goods and services the mark RAW and a family of RAW-formative marks (collectively, the “RAW Marks”), which RAW-formative marks at various times have included but are not limited to RAW CORRECT, RAW CROSSOVER, RAW ESSENTIALS, RAW NIGHTS, RAW DNM, RAW FERRY, RAW FLASK, RAW SUSTAINABLE, THE ART OF RAW, and RAW TAILORED ATELIER.

3. G-Star has extensively used and promoted the RAW Marks both individually and collectively. Through this extensive promotion and use, and the success of G-Star's offerings under these marks, G-Star's RAW Marks have come to represent enormous goodwill of G-Star.

4. Dating to long before any date upon which the applicant can rely, G-Star's RAW Marks, both individually and collectively, have become uniquely identified with G-Star and have come to identify the goods and services of G-Star exclusively.

5. In addition to G-Star's common law rights in the RAW Marks developed through many years of use, G-Star owns the following federal registrations for certain of the RAW Marks:

The foregoing registrations are valid, subsisting, and in full force and effect. These registrations constitute evidence of the validity of the registered marks and of the registrations thereof, of G-Star Raw C.V.'s ownership of the marks, and G-Star Raw C.V.'s exclusive right to use the marks in commerce in connection with the identified goods and services, all pursuant to Section 7(b) of the Lanham Act, 15 U.S.C. § 1057(b). The registrations also place others on constructive notice of G-Star Raw C.V.'s claim of ownership thereof, pursuant to Section 22 of the Lanham Act, 15 U.S.C. § 1072. True and correct copies of printouts from the U.S. Patent and Trademark Office online Trademark Status and Document Retrieval ("TSDR") database showing the foregoing registrations are attached hereto as Exhibit 1.

6. Upon information and belief, the owner of the application at issue ("Applicant") is Earth Lab Cosmetics, a sole proprietorship composed of Scott MacDougall, a citizen of Canada, with the address of 5190 Robinson Place, Peachland, British Columbia V0H 1X1, Canada.

7. Upon information and belief, on or about June 7, 2012, Applicant filed Application Serial No. 85/645,677 (the "Application") to register the mark RAW MASCARA ("Applicant's Mark") for "Mascara" in International Class 3 under Section 44(e) of the Lanham Act, 15 U.S.C. § 1126(e).

8. Applicant is not connected to G-Star in any way, and has not been authorized by G-Star to use Applicant's Mark.

9. Upon information and belief, G-Star's rights in the RAW Marks are prior and superior to any rights Applicant may claim in Applicant's Mark.

10. Applicant's Mark incorporates G-Star's RAW mark in its entirety and is highly similar to G-Star's RAW Marks, individually and collectively, in appearance, connotations and commercial impression.

11. The goods identified in the Application are identical and/or closely related to goods offered by G-Star under the RAW Marks and/or for which G-Star owns federal trademark registrations.

12. As a result of the similarity of the marks and the goods, and other considerations, use by Applicant of Applicant's Mark for the goods identified in the Application is likely to create the erroneous impression that Applicant's goods originate with, are sponsored or approved by, or are otherwise connected with G-Star or with one or more of the RAW Marks or the goods provided by G-Star under those marks. Any use of Applicant's Mark by Applicant is, therefore, likely to cause confusion, cause mistake or to deceive the public, in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

13. As a result of the foregoing, registration to Applicant of Applicant's Mark would be inconsistent with G-Star's prior exclusive rights in the RAW Marks and would threaten to


destroy G-Star's investment and goodwill in the RAW Marks. G-Star therefore will be injured by registration of Applicant's Mark.

WHEREFORE, G-Star respectfully requests that this opposition be sustained and that registration to Applicant's Mark in all respects be denied.
