Opposer Sac Acquisition, LLC, a limited liability corporation of Delaware with a principle place of business at 700 Canal Street, 4th Floor, Stamford, Connecticut 06902, believes that it will be damaged by registration of the mark shown in United States Trademark Application Serial No. 79/107,765, in International Classes 018, 025, and 035, and hereby opposes the same. The grounds for the opposition are as follows:

1. Upon information and belief, De Fursac (“Applicant”) is a French corporation having an address of 112, rue de Richelieu F-75002 Paris, France. Applicant seeks to register the mark “DE FURSAC” as a trademark in International Classes 003, 018, 025, and 035, as evidenced by the publication of such mark in the Official Gazette on TM 24 of the March 26, 2013 issue. Applicant’s goods and services identified in United States Trademark Application

Serial No. 79/107,765, in International Classes 018, 025, and 035 are listed in Exhibit A attached hereto.

2. Applicant filed its application for registration for such mark under 15 U.S.C. § 1141(f) on September 29, 2011, and received an application serial number of 79/107,765.

3. For many years and long prior to the effective filing date of the subject application, Sac Acquisition, LLC and its predecessors in interest (collectively referred to herein as “Sac Acquisition”) have been engaged in the development, manufacture and sale of a variety of goods and services, including various kinds of furniture, bags, clothing, headgear, and retail store services, all offered and sold in interstate commerce throughout the United States and the world, in association with the registered, pending, and common law trademarks of Sac Acquisition. The goods and services offered by Sac Acquisition in association with such registered, pending, and common law marks are such that the consuming public will likely be confused as to the source of the goods offered by Applicant.

4. Sac Acquisition is the owner of the following relevant United States trademark registrations which have duly and legally issued by the United States Patent and Trademark Office:

5. Since the date of issuance of the above registrations, the marks have been continuously used in interstate commerce. Since the issuance of these trademark registrations, notice has been given to the public that the marks are registered trademarks by affixing notice provided in 15 U.S.C. § 1111.

6. Sac Acquisition is also the owner of the following trademark application which is pending at the United States Patent and Trademark Office:

7. In addition, prior to the effective filing date of the subject application, Sac Acquisition has developed and used a family of trademarks incorporating the word “SAC” in association with, on or in connection with various goods and services, including furniture, bags, clothing, headgear, and retail stores, in association with the registered, pending, and common law trademarks of Sac Acquisition in interstate commerce throughout the United States, including but not limited to:

LOVESAC
LOVESAC with design
LOVESAC LIFE
SAC
SUPERSAC
COMFORTSAC
COOLSAC
CHILLSAC
GAMESAC
PETSAC
LIKESAC
ANIMALSAC
MOVIESAC

8. For many years and long prior to the effective filing date of the subject application, Sac Acquisition has continuously used its “SAC” marks in interstate commerce.

9. Sac Acquisition’s “SAC” marks are distinctive and serve as a unique designation of origin with respect to goods and services offered by Sac Acquisition.

10. In addition to the rights inherent in each of the “SAC” marks, Sac Acquisition has also acquired broader rights to the “SAC” marks as a family of marks.

11. Sac Acquisition has used its registered, pending and common law trademarks in its “SAC” family of marks to distinguish its goods and services from all other goods and services of the same type. The “SAC” marks owned by Sac Acquisition are distinctive and serve as a unique designation of origin with respect to the goods and services offered by Sac Acquisition. In addition, since long prior to the effective filing date of the subject application, Sac Acquisition has acquired substantial goodwill in its “SAC” family marks and names through use thereof under 15 U.S.C. § 1125(a).

12. Since Sac Acquisition’s initial use of its various “SAC” marks, Sac Acquisition has made a substantial investment in marketing and promoting its goods and services under its “SAC family of marks. Sac Acquisition has extensively used, advertised, promoted and offered for sale goods and services in association with its “SAC” marks with the result that Sac Acquisition’s customers and the general public have come to know and recognize Sac

Acquisition's "SAC" marks and that the public associates these marks with Sac Acquisition and/or its goods and services. Sac Acquisition has built up extensive goodwill with the sale of goods and services under its various "SAC" marks.

13. Notwithstanding the inherent distinctiveness of its "SAC" marks, said "SAC" marks have also acquired secondary meaning to the public indicating Sac Acquisition as the source of goods and services bearing any of Sac Acquisition's "SAC" marks.

14. Applicant's mark wholly incorporates Sac Acquisition's trademark "SAC" and the "sac" portion of Applicant's mark is identical in sound, spelling, and appearance to the "SAC" portion of Sac Acquisition's "SAC" marks. The mark proposed for registration by Applicant, namely "DE FURSAC", is applied to goods and services that are closely related, and in some cases identical, to the goods and services provided by Sac Acquisition under its "SAC" marks. Applicant's mark coupled with the goods and services for which registration is sought so nearly resembles one or more of Sac Acquisition's "SAC" marks used on similar goods and services, so as to be likely to be confused therewith and mistaken therefore and to confuse, mislead and deceive the consuming public as to the source or origin of Applicant's goods and services.

15. A likelihood of confusion in the marketplace exists between Sac Acquisition's "SAC" trademarks and Applicant's trademark when applied to the goods and services of the respective parties.

16. Registration of Applicant's trademark will result in damage to Sac Acquisition's trademarks and Sac Acquisition's business.

17. If Applicant is permitted to register its mark for its goods and services as specified in the application herein opposed, such use and registration would result in confusion in the trade by reason of the similarity between Applicant's mark and one or more of Sac Acquisition's "SAC" marks, thereby damaging and injuring Sac Acquisition. Any such confusion may result in the loss of business to Sac Acquisition. Furthermore, any defect, objection or fault found with Applicant's goods and services marketed under the "DE FURSAC" mark may reflect upon and

injure the reputation which Sac Acquisition has established for its goods and services in association with one or more of Sac Acquisition's "SAC" marks.

18. If Applicant is granted the registration in the classes of goods and services herein opposed, it would thereby obtain at least a prima facie exclusive right to the use of its mark. Such registration would be a further source of damage to Sac Acquisition.

19. In view of the forgoing, Applicant is not entitled to federal registration of its claimed mark because Applicant's mark as used upon the identified goods and services being opposed is not entitled to protection. Further, Applicant does not have a right to exclusive use of said mark in commerce on Applicant's goods and services opposed herein. Applicant's claimed mark does not and cannot function to identify such goods and services and to distinguish them from goods and services offered by Sac Acquisition.

WHEREFORE, Sac Acquisition requests that the registration sought by Applicant be refused and that this Opposition be sustained.

The fee required under 37 C.F.R. § 2.6(17) is submitted herewith.
