(hereinafter the “S.P.I.R.E. Mark”). In accordance with 37 CFR § 2.122(d)(1), attached hereto as exhibits are printouts from the electronic database records of the USPTO showing the current status (**Exhibit A**) and title of the registration (**Exhibit B**) listed above.

5. Notwithstanding Opposer’s prior rights as described above, Applicant, Geneva Area Recreational, Educational and Athletic Trust (“Applicant”) seeks registration of Serial No. 85/714,936 for the mark SPIRE for use with the following:

Sports Training and Education Programs, namely, programs for athletes to improve athletic performance; Educational services, namely, four year high school curriculum courses, instruction and training in swimming, soccer, track and field, lacrosse, volleyball; training programs to improve physical athletic performance; providing seminars, workshops, and classes in the field of sports, and the publication and distribution of course materials in connection therewith; sports refereeing and officiating, providing instruction in sports refereeing and officiating; Providing courses of instruction in the field of Sports Management, Physical Training, Sports Medicine, Broadcasting, and Journalism; Providing training in the field of mental conditioning for athletes and others for improved performance in sports and athletic activities, life skills, and other activities; Physical fitness training services; Physical fitness conditioning classes; Life skills training, namely, providing mentoring and training to youths, athletes, and others to improve personal character traits, namely, organization, community service, etiquette, sportsmanship, and cultural awareness; Providing information relating to sports, arts and entertainment by means of a web site of the global computer

6. On August 28, 2012, Applicant filed Application Serial No. 85/714,936 alleging first use of SPIRE on September 30, 2011.

Count I: Likelihood of Confusion

7. Opposer hereby incorporates by reference the allegations in Paragraphs 1-6 as if fully set forth herein.

8. Opposer's and/or its predecessor in interest's date of first use in commerce in the United States of the S.P.I.R.E. Mark precedes the date of first use stated in Application Serial No. 85/714,936.

9. The filing date of the application to register the S.P.I.R.E. Mark precedes the filing date of Application Serial No. 85/714,936.

10. The use and registration by Applicant of SPIRE in connection with Applicant's recited services will enable Applicant to utilize and trade upon the goodwill established by Opposer in its valuable S.P.I.R.E. Mark, thereby damaging Opposer.

11. Applicant's alleged mark, when applied to the services recited in Application Serial No. 85/714,936, is likely to cause confusion or mistake or to deceive, and will deceive and mislead the trade and the purchasing public into believing that Applicant's services are the services of Opposer, or that Applicant's services are sponsored, approved or endorsed by

Opposer, or that Applicant is authorized, licensed or controlled by Opposer, or that Applicant is a division or subsidiary, or in some way related to Opposer.

12. Applicant's alleged SPIRE mark is not registrable under Section 2(d) of the Lanham Act in view of Opposer's prior, continuous and ongoing use in interstate commerce in the United States and registration of its S.P.I.R.E. Mark.

RELIEF

WHEREFORE, the Opposer prays for relief as follows:

- A. That Application Serial No. 85/714,936 be rejected, that no registration be issued to Applicant, and that this Opposition be sustained in favor of Opposer, Delta Education, LLC.
- B. For such other and further relief as the Trademark Trial and Appeal Board deems proper.
